 mentioned, Viz, John Harvy, William Harvy, Thomas Harvy, Gaspingham
 Harvy, Sarah Howl, Francis Harvy, Elizabeth Paulet and Drusilla
 Harvy; Item I also give unto my Daughter Francis Harvy my saddle Horse
 to her and her heirs forever; Item I do disallow any Claim or demand to be
 brought against my Estate by my Children before mentioned and should
 any be brought I do order that it shall be deducted out of the said Claimants
 Legacy; I do hereby Constitute, appoint and ordain my son in law Thomas
 Paulet, and my Friend Robert Jennings and my son Thomas Harvy Executors
 to this my Last Will and Testament, (I do Impower them to make a Leght
 to my Land in Georgia) hereby Revoaking and annulling all former Wills
 In Witness whereof I have hereunto my hand and affixed my seal this day
 and year above mentioned.

Exhibited in Court by Thomas Padgett and Thomas Harvy two of the
Executors Therein Named and the same was proved by the Oath of Henry
Madison, Joseph Barksdate and William White the three Witnesses
hereto subscribed and ordered to be Recorded, On the Motion of the said
Executors who made oath according to Law Certificate is Granted them
for Obtaining a probate of the said Will ^{in due form}, they giving security whereupon
they together with William White and Henry Madison their securities
entered into and Acknowledged their bond for that purpose, Reserving
Liberty to Robert Sening the other Executor to Join in the Probate thereof when
he shall think fit
