It is ordered that the sum of 100^l be paid for

be brought by the Inhabitants of the South Side to
the mill at Bowdell's Brook, and that the Court
order the said mill and that the Court order the
wardens to be the small Southerners of the said pipe
who in case of neglect and thereby incurred a way
find out & carried & the tollmen 110^l toll, & so proportionally
to be returned by distress if needfull.

The Court hath granted to the Inhabitants of the parish of 14
days from the date hereof for performance of the order
and command for payment of the bound & some & ordered
that the said or his deputy give satisfaction to the Court
of the Court, & command to the performance thereof, in
default whereof the said or his deputy or default are
thereby adjudged to pay 110^l toll for each barrel, & so
proportionally at the next Court, vizt 100^l per barrel &
10 for tollmen to be returned by distress in case of refusal.
