 I give and bequeath to my loving Nephew John Duguet son of my sister Helen Gordon wife of James Duguet in the parish of Dumbell and place called Goffs head, in the Shire of Aberdeen in North Britain the sum of eighty pounds Sterling
 I give and bequeath to Capt Hugh McClaue of Greenock in North Britain the sum of ten pounds Sterling and a mourning ring.
 I give and bequeath to my good friend Mr John Peyton Attorney General a mourning ring.
 I give and bequeath to Mr Mary Harrison widow of Col Nathaniel Harris ten to her and each of her Children one mourning ring.

All the rest of my Estate Lands Negroes Stocks of Catell Debts Moneys and all sort of Estate what ever real or personal I give and bequeath to my loving friend Archibald Blair of the City of Williamsburgh to him and his heirs for ever and do also appoint the said Archibald Blair sole Executor of this my last Will and Testament hereby Revoking all Wills by me formerly made. In witness whereof I have hereunto set my hand and Seal this first of May 1728: in the first year of the Reign of his Majesty King George the second.
