Item I give and bequeath unto my Son John that part of my land co-
lyeth on Gilleys Run from a Corner pine Tree and So along the
Said line Northerly to Two Red Oaks, It being the land I formerly
purchased of Edward New of this County Containing by Estimation
fifty acres ^{both} more or less to him and his heirs for ever

Item I give and bequeath unto my Son William Rock that part of my
land which lyeth from those Two Corner Red Oaks above
Mentioned to two Corner trees Standing upon the Side of Stokes's
Road (viz) a Red and a Spanish Oak, marsh, and So back Southerly
down a Valley to the head of a branch and So along the Said branch
back to the above Said Gilleys Run Containing by Estimation fifty
acres be it more or less being purchased of Edward New as
above to him and his heirs for ever

Item I give and bequeath unto my Son Henry Rock that part of my land
from the Corner Tree of the land which I gave my Son William
Counting on Gilleys Run & So along the Said Run West & by North
or thereabouts to two Corner Trees of Samuel Pals (viz) a white
oak and a pine being both Marsh Standing in Gilleys Run and
from thence coming over the Run Northerly along the Side
of a Small branch & So along as the branch and Valley runneth
to a great old Standing pine at the head of the Said branch and
So along the Said Valley to Stokes's Road to him and his heirs lawfully
enjoyed for ever

Item I give and bequeath unto my Son Henry a Gun which
he hath used a Carabine Pistols Holders & Sword a Saw Case
and a Case

Item I give and bequeath unto my Daughter Mary Chirn one Shilling

Item I give and bequeath unto my Daughter Sarah Ten Shillings Curr Money
