I Item I give unto my Loving Son Marston Duke Six Negroes now in his possession by Name, Sam, Peter, Jerry, Sam boy, Hannah & Jack, all in his possession, to him & his heirs for ever
 Item I give unto my Said Son all the Cattle, Hogs, & Household stuff at Black Lark ^{now in his possession}
 Item I give unto my Said Son my Gun to be delivered him at my death
 Item I Give unto my Loving Daughter Swanna (Wife to Michael Sherman) four negroes two of which are now in her possession named Jerry & Henry the other two are to be delivered to her at the finishing of the Crop named old Jerry & Phillis, which 4th four negroes I give unto my S^d Daughter Swanna & her heirs for ever
