I give and bequeath unto my son Lightfoot Jby my Negroes Anthony and Ben to him and his forever. Item I give and bequeath unto my son Henry Jby my Negroes Will Foster and Jack to him and his heirs forever. Item I give and bequeath unto my daughter Betsey Jby, Aggy and her two children Joe and Nancy and an old Woman Fanny to her and her heirs forever. Item I further give and bequeath unto my said daughter Betsey Jby all my plate, one feather bed and furniture and my large looking glass to her and her heirs forever. Item after my just debts are paid I give the balance of my estate of every kind whatsoever may be equally divided between my said sons Lightfoot and Henry Jby to them and their heirs forever. Lastly I do hereby appoint my friends the Honble John Tyler and Mr Francis H Dancy Executors of this my last Will and Testament revoking all other Wills by me heretofore made. Tending that in my aforesaid last Will and Testament I have not made sufficient provision for my daughter Betsey to my will and duty, that, in addition to what I have already given her in my said will, she shall have a third part of the profits arising from the hire of all my negroes untill she marries or arrives to lawful age Mr Tyler not wishing to take upon himself the burthen of the administration of my estate I do hereby constitute and appoint my friend Francis H Dancy sole executor of this my last will and Testament and codicil annexed this twenty fourth day of June 1798
