Will

In the name of God amen I Rebecca Walker of Charles City  
 County and Parish of Westover do make and ordain this writing to be  
 my last Will, and Testament in manner and form following to wit —  
 I give and bequeath unto my son Henry Walker one Negro boy named  
 Davey to him and his heirs forever — Item I give and bequeath unto  
 my son John Walker one negro boy called Frederick to him and his  
 heirs forever — Item I give and bequeath unto my daughter Elizabeth  
 Lacy one Negro woman called Hannah, one Negro Girl named Mary  
 with all their future increase, to her and her heirs forever, also my aged  
 Chair — Item I leave all the residue of my estate of what kind soever,  
 after first paying all my just debts, to be equally divided between all  
 my aforesaid Children, to wit, Henry, John, and Elizabeth to them, and  
 their heirs forever — Lastly I nominate, and appoint my son Henry  
 Walker, and John Walker Executors of this my Will revoking all others  
 by me made. In Witness whereof I have hereunto affixed seal, and  
 subscribed my hand this 29<sup>th</sup> day of September 1793. —

At a monthly Court held for Charles City County on Thursday the eighteenth  
 day of December 1794 The afore written last Will and Testament of  
 Rebecca Walker deceased was this day proved by the oaths of Wyatt Walker &  
 Edward Clarke the witnesses thereto and ordered to be recorded. And on the  
 motion of Henry Walker one of the Executors therein named, who made  
 oath thereto as the Law directs, and together with John E. Bailey, William  
 Parrish Jun<sup>r</sup> and Edward Clarke his securities entered into and acknowledged  
 their bond in the penalty of One hundred and fifty pounds with condition  
 according to Law, Certificate is granted him for obtaining a probate thereof  
 in due form. Liberty is reserved to the other executor therein named, to join  
 in the probate when he shall think fit. —

At a monthly court held for Charles City County on Thursday the nineteenth day of February 1795, The afore written last Will and Testament of David Wilkinson deceased was this day proved by Michael Maddox and Thomas Benford two of the witnesses thereto and ordered to be recorded. And the Executors therein named appeared in court and refused to qualify, and on the motion of Richard Wilkinson and making oath thereto as the law directs, and together with James Bradley and John Bradley his securities entered into and acknowledged their bond in the penalty of four hundred pounds with condition according to law, Certificate is granted him for obtaining letters of administration with the said Will annexed in due form.
