

We Elizabeth Bullington and John Drake both of the age of 21 years or upwards do hereby Certify that during the last sickness of Porterfield Bradley late of this County, of which he died, & at the place where said Bradley resided for the last three months immediately preceding his death, he the said Porterfield called on said Jno Drake who was then present to bear testimony that in case of his death he gave what Estate he was entitled to by the death of his father & brother James to be equally divided between his brother Spotswood Bradley & half brothers John Drake & Rheubin Francis. That what estate he possessed independent of his brother & father's deaths as aforesaid he disposed of in the manner following - To Rheubin Francis a bond or note given by said Francis to s^d decedent, a note of James Ware & a part of his Corn & fodder. To John Drake his horse saddle & bridle & the balance of his Corn & fodder. And to Gideon B. Drake & James Irvine Drake Children of said Jno Drake he gave all the rest & residue of his estate which he possessed independent as above stated. We also certify that said Porterfield Bradley died on the night of the 7th April 1815. Given under our hands this 12th day of April 1815. -
