

In the name of God Amen: I Thomas Gannaway of the County of Charles City being sick (and weak in body but of sound mind and memory) do ordain constitute and appoint this my last Will and Testament revoking all other or former Wills heretofore made by me in manner and form following: First I Give to my friend Reuben Francis all my Estate both real and personal to him and his heirs for ever - Secondly and lastly I do appoint my friend Reuben Francis Executor to this my last Will and Testament to have the privilege of acting freely without being oblig'd to render security to the County Court or any other Court or person whatever. Given under my hand and seal this twentieth day of June one thousand eight hundred and sixteen

At a Court held for Charles City County at the Courthouse the 18th day of July 1816. This writing purporting the last will and testament of Thomas Gannaway and was produced in Court by Reuben Francis the Executor therein named in order to be proved and on the motion of Gannaway Morgan the proving thereof is continued till the next Court; at which time to wit at a Court held for the said County as aforesaid the 15th day of August following. The said writing was proved by the oaths of all the witnesses thereto and ordered to be recorded: And on the motion of Reuben Francis the executor as aforesaid who made oath according to law and entered into and acknowledged a bond in the penalty of Twelve hundred dollars conditioned as the law directs (no security being required by the will) certificate is granted him for obtaining a probat thereof in due form.

security:- In testimony whereof I have hereunto ^{set} my hand & affixed my seal this sixteenth day of March one thousand eight hundred & fifteen
