Item I give & bequeath to my Daughter Judith Frankson & to her Heirs & Assigns
forever one Negro Girl named Molly

Item I give & bequeath to my Daughter Elizabeth Winfrey & to her Heirs & Assigns
forever one Negro Girl named Agnes on half

Item I give & bequeath to my Daughter Ann Winfrey & to her Heirs & Assigns
forever one Negro Girl named Mary also on half

Item I give & bequeath to my Daughter Sarah Winfrey & to her Heirs & Assigns

for ever one Negro Girl named Liberty also one boy & half

Item I give & bequeath to my Daughter Sarah Winfree to her Heirs & Assigns

for ever one Negro Boy named Charles also one boy & half

Item I give & bequeath to my son Archibald Winfree to his Heirs & Assigns

for ever one Negro Boy named Oliver

Item I give & bequeath to my son Mathew Winfree to his Heirs & Assigns

for ever one Negro Boy named John

Item I give & bequeath to my son Maxwell Winfree to his Heirs & Assigns for ever

one Negro Boy named Abram

Item I give & bequeath ^{unto} to the child that my Wife Judith ^{Winfree} now goes with to her

& Assigns for ever one Negro Boy named James

Item I lend to my living Wife Judith Winfree the Land & Plantation whereon

I have remaining one hundred & fifty acres of land also six negroes To wit I have bequeathed
George Spencer & his heirs also all the residue & remainder of my Estate both real & personal together
Dwelling without during his natural life after the decease of my said Wife I give the said Land &
Negroes to my son Samuel Winfrey & to his heirs & assigns forever

I give the negro named Lucy to my son Archibald Winfrey & to his heirs & assigns forever

I give the negro named Grace to my son Mathew Winfrey & to his heirs & assigns forever

And my Will & Desire is that all the rest of my Estate that I have to my living Wife be
equally divided between all my Children my Will & Desire is that my Estate may not be
appraised

Lastly I do nominate constitute & appoint my loving Wife Archibald Winfrey Esq. one of
my friends Archibald Withall Esq. Peter Franklin my sole Executors to this my last Will
& Testament hereby revoking & disannulling all other & former Wills heretofore by me made

my former Archibald Withall's & Peter Franklin my wife's estate & this my last Will
Testament hereby revoking & disannulling all other of James Wills heretofore by me made
