Wooden Wheel a ~~great~~ iron and a ~~chain~~ a candlestick and  
a frying pan which I give and bequeath to her and her heirs forever.

Item I give and bequeath to my Daughter Betsey Jackson and to  
her heirs One feather Bed and furniture a Chest and a  
Hunting Saddle a ~~Wagon~~ Wheel and Cards a great Dish  
and five plates a Lunch Bowl and Tumbler a ~~Iron~~ Iron two  
Chairs and a foot Adir which Feather bed and other things  
I give and bequeath to her and her heirs forever.

But should my Daughter Betty Jackson die without a lawful heir  
my last and true will is that all her part of my estate should
