Widowhood & the use of the Plantation I now live on together with all my other

Estate consisting as follows To Wit nine Negroes named Mary Susan

Hampshire Tom Lidd Jack James Phillis & Prilley & all my House

Hold & Kitchen Furniture Stock of cattle Sheep Hens Hogs & every all

the aforementioned articles I leave unto the use of my aforesaid Wife during

the time she remains my widow or less & no longer

Now I give & bequeath unto my Son Russell Braugh after my aforesaid

Wife decease or second ^{the} marriage aforesaid Plantation I now live

on being the same I leave to my Wife containing by estimation three hundred

Item I give & bequeath unto my Son Duwrell Baugh after my aforesaid
one Wife decease or second marriage, ^{the} said plantation I now live
on being the same I lent to my Wife containing by estimation three hun-
dred acres to the same more or less together with the sitting place & all
privileges advantages profits & emoluments thereunto belonging to wit
the only proper use of them my Son Duwrell Baugh & his Heirs & assigns
forever

Item I give & bequeath unto my aforesaid Son Duwrell Baugh after my aforesaid
Wife decease or second Marriage all my other Estate that I lent ^{to} my aforesaid
said Wife consisting as follows To Wit being nine Negroes named Henry
Jude Hamshiro Tom Lida Jack James Phillis & Billey & all the increase
that shall or may arise from any of the aforesaid Negroes forever
after the assignement of this Will together with all my other Estate I now have

I desire & request that my son Russell Brough be to be
take the full proper use of him my said son Russell Brough & his
his heirs & assigns forever.

Item I give & bequeath unto my son Russell Brough & his heirs
& assigns, one Lot of Land in the town of Falmouth in the
unfield County & Parish of Dale

I also appoint my said son Russell Brough my
whole & sole Executor to this my last Will & Testament making
null & void all other Wills by me made Desiring my estate
may not be appraised And No Witnesses whereof I have
hereunto set my hand & affixed my seal This nineteenth day
of October in the year of our Lord Jesus one thousand seven
hundred & sixteen then

& Appoints one Lot of Land in the town of Salisbury in the
Wesfield County & Parish of Dale

I also appoint my afsaid Son Russell Bough my
whole & sole Executor in this my last Will & Testament making
null & void all other Wills by me made Desiring my estate
may not be appraised and No Witnesses whereof I have
testimony set my hand & affixed my seal this nineteenth day
of October in the year of our Lord Christ one thousand seven
hundred & seventy three
