Memorandum

Whereas my Husband John P. of the County of York has in former times of his
life and during his life given me the Privilege of freely using and disposing of
such manner as I please within by will or Appointment of certain Slaves and other Personal Property
specifically in his will. In Execution of the Power so given me I Maria P. do give and
bequeath to my Son Robert P. P. John P. P. and William P. P. and to the Survivors of
them and to the Heirs of them the following Property to wit: One Estate of the
Value of all the same as follows at my Death of which then hereinafter specifically devised to my Son
John P. P. my Youngest Daughter by the will of John P. P. the Father of the Female who
the Heir of all the same in the above the said John P. P. at the Time of my Death by

my Husband, to have and to hold the same, Slaves and other Property, to the special Use of my Daughter
Mary W. Humes and her Heirs as in and to the same what time to be subject to the Right of Control
of her Husband, giving to the same Mary W. the Power to dispose of the same by Will or Appointment or
by written Directions to the said Trustee, during her Life and giving her full Power to direct the said Trustee to
manage the same in such Manner as she may think proper, so that she may receive the Principal and the
Profits to her special Use - her Executors or Administrators in all Cases and Things pertaining to the said
Property, a full and complete Discharge to the said Trustee, both in Law and Equity from all Responsi-
bility. And upon her Death to have and to hold the said Property in so much of it as may remain
undisposed of to the like and same Part of John Philpott and her Heirs in equal Proportions to be suc-
ceeded to them as they respectively attain them in full Age - in and from this Trust.

And I have and bequeath to my said Sons, John P. John E. and Matthew P. and to the
Survivors of them and to their Heirs and Survivors the following Property to hold to the Equal Part of
my said Sons and their Heirs as in and to the same what time to be subject to the Right of Control
of my said Sons and their Heirs and Survivors of the same of Nelson with the Successors of the same, also one
Half of all the same and to the said John P. John E. and Matthew P. at the Time of my Death and my
Husband to have and to hold the same Slaves with the full Successors of the same to the said Property
to the special Use of my Daughter Mary W. and her Heirs as in and to the same what time to be subject to the Right of Control
of my said Sons and their Heirs and Survivors giving to the same Mary W. the Power to dispose of the same by Will or Appointment or
by written Directions to the said Trustee, during her Life and giving her full Power to direct the said Trustee to manage the same in such Manner as
she may think proper, so that she may receive the Principal and the Profits to her special Use - her Executors or Administrators in all Cases and Things pertaining to the said
Property, a full and complete Discharge to the said Trustee, both in Law and Equity from all Responsi-
bility. And upon her Death to have and to hold the said Property in so much of it as may remain undisposed of to the like and same Part of John Philpott and
