In the name of God Amen I Thomas Pinck of Culpeper
County do make this my Last will and Testament.

I lend to my loving wife Margot Pinck my whole Estate both Real & Personal
During her natural life she supporting & Educating my son Thomas & my
Daughter Ruth until they arrive to the age of sixteen years
Item My will and Desire is that if my wife should Die before my son
Thomas should arrive to the age of sixteen years that my Executors

hereafter named shall support & educate my said son untill he should
Arrive to the said age at which Time I desire that he may be bound to some
Trade or Employment by my said Executors untill he shall arrive to the
Age of Twenty one Years

Item my will and desire is that after the Death of my said wife and after my
said son Thomas shall arrive to the age of sixteen years that my lands
whereon I now live shall be Equally Divided according to Quantity and
Quality between my two sons John and Thomas to them & their heirs forever
and if either my sons should die before such Division leaving Issue
that their part shall Devolve to such Issue of if either should die before
such Division without without Issue in such case I give and bequeath
the whole to the survivor and his heirs forever and if both my sons
should die before the time such Division would have been made with-
out Issue in that case my will and Desire is that my Land shall be
sold and conveyed by my Executors hereafter named or by the survivor
or survivors of them or by such as shall choose to Qualify and act as
Executors and the money arising by such sale to be Equally Divided
Between my daughters or their Legal Representatives

Item my will and Desire is that after the death of my said wife and after my son Thomas shall arrive to the age of sixteen years that all the rest of my Estate shall be sold by my Executors and the money arising by such sale shall be Equally Divided between all my Children.

Item my will and Desire is that if any of my children should Die before such sale & Division leaving Issue that such childs Part shall be Equally Divided such Issue and if any of my children should Die before such Division without Issue that such childs Part shall be Equally Divided between my other children or their ^{Supper County Virginia Wills} ¹⁷⁷⁰⁻¹⁷⁸³ ^{www.virginiapioneers.net} Representatives.

Lastly I nominate and appoint Henry Field and William Walker & my son John Pinor Executors of this my last will and I do hereby Disannul all other wills by me heretofore made Declaring this only to be my last will & Testament. In witness whereof I have hereunto set my hand and seal this 17th day of April in the year one thousand seven hundred & twenty six.
