with Eight hundred acres of land adjoining the same in Goochland  
County also I give him four hundred Acres of land in the Same County on  
Dear Waller also also Four Negros to wi - Jack Lucy Old Hannah and Ben  
also I give him my Desk all which I Give to him and his Heirs for Ever -

Item I give to my Son William Cox Seven hundred and Sixty Three  
Acres of land in Goochland which I purchased of Young Stokes  
also I give to my Son

with Eight hundred acres of land adjoining the same in Goochland County also I give him four hundred Acres of land in the Same County on Tice Mallet also also Four Negros to wit Jack Lucy Old Hannah and Ben

also I give him my Desk all which I Give to him and his Heirs for Ever -

Item I give to my Son William Cox Seven hundred and Sixty Three

Acrees of land in Goochland which I purchased of Young Stokes

also I give to him Three negros to wit Anania Ned and Sam

all which I Give to him and his Heirs for Ever -

Item I give to my son Josiah Cox Three hundred Eighty One acres of

land in Amelia County which I purchased of Edmund Franklin to

him and his Heirs for Ever -

Item I give to my Daughter Judith Cox Four Negros to wit Assur

ney, Little and Glasgow and one feather bed and Furniture all which

I give to her and her heirs for Ever -

Item I give to my Daughter Elizabeth Cox Four enros to wit John

the younger, Norman and Frank and One feather bed and Furniture.

so her and her heirs for Ever -

This my will and Desire is that when my Son Josiah Comes to the

age of twenty one years that my two Negro Women to wit Jenny

Will Moll — together with their Increase be Equally Divided to

my five Children to wit Josiah Sarah Mary Tabitha and Martha

Cuffee Sarah and Betty and all the Remainder of my Personale Estate

During her Naturale Life and and after Her Decease my Will and

Desire is that the Same be Equally Divided to all my Children

Item My will and Desire is that not any Part of my Estate be

Appraised but remain in the hand and Possession of my loving wife Judit

Cox.

Item I Constitute and Appoint my Friedd Henry Wood and my Son

Stephen Cox and my Loving wife Judith Cox to be my Whole Executors

to execute this my last will and Testament Ritifying and Confirming it
