

In the name of God amen. I John Mäfenbunge
of Elly City County being sick & weak of body but of sound and
perfect memory (Thanks be to Almighty God) do constitute ordain
and appoint this to be my last Will and Testament Revoking and
disanuling all former Wills or Testaments by me heretofore made in
manner & forme following vizt.

Item I give and bequeath my soul to God that gave it & my body to the
Earth from whence it was taken in sure and certain hopes through
the Merits & sufferings of my blessed Saviour Jesus Christ to receive
a joyfull resurrection at the last day & as to my worldly Estate I give
and dispose thereof as followeth.

Item I give & bequeath unto my loving Son John Mäfenbunge one
hundred & fifty two Acre Land part of y^e Plantation I now live in
to be laid off & going on y^e Land of Land Tenbury with my House
Guardain & Orchards to have & to hold to him the said John (and his
heirs forever) and if my son John should never come to Possess y^e
said Land that then it be Equally divided between my two sons
Lacharath & Robert to them & their heirs for ever.

Item I give and bequeath unto my two loving sons Nicholas & Josiah
Mäfenbunge the remainder except the one hundred & fifty two Acres
before given to my son John of my tract or Parcel of Land I now live
on to be equally divided between them & that my son Nicholas have
that Part called known by y^e name of Land of furs. to have & to hold
to them the said Nicholas & Josiah and their heirs for ever.

Item I give to my Daughter Susanah one negro boy named Andrew & one
girl named Judy, and one bed & furniture to her & her heirs.

Item I give to my daughter Walsery one negro boy named Jupiter a girl
named Danner & one bed & furniture to her & her heirs.

Item I give to my Daughter Elizabeth one negro boy named Sam a Negro girl
named Phely and one Bed & furniture to her & her heirs.

Item I give to my Son Lacharath two negro boys named Jack & y^e Glascon
and ten Pounds in Cash to him & his heirs.

Item I give to my son Robert one negro boy named Jamey & one girl
named Sue and ten Pounds in Cash to him & his heirs.

Item I Lend the Use and Labour of eight Negroes by name Sam,
Cassim Limbrick, Joshe Pompey, Dan. Mudes, Lufey all my household
furniture except what I have before given away and all my stock
of cattle sheep Hogs Horses &c unto my loving wife Barbory
Mafsonburge During her natural life. & my will is that all
my children may live with my loving wife and the Estate lent
her till they marry or are otherwise provided for.

Item My Will and desire is that if any of those ten Negroes given
to me five children Susanah Barbory, Eliz. Tachariah, & Robert
should die before they take of said Negroes in Possession that then
they be made whole out of the Increase of those Negroes lent to my
loving wife.

Item My Will is that if my loving wife Barbory should marry
after my death & then the said Barbory should lose all dower
and Advantages given her in this Will.

Item My Will is that what Money I have in the House & that I have lent
out by Money & aifer from of Present brood & stock if any sold
be by my executors laid out in negroes as soon as conveniently may be
and that my loving wife have the Use & labour of those Negroes living
During her Natural life.

Item my Will is if my Executors have full Power to sell any of my Old
Negroes by buying others in there Room.

Item My Will & desire is that all the Estate I have lent & Entrusted
my wife with after her death be Equally divided amongst all
my children then alive, or there children if they are dead if they leave
any to them by their heirs.

My Will is that my Executors shall not give Security
for my Estate nor render an Inventory nor apprais.

I hereby constitute Ordain and appoint my loving wife
& two Sons Nicholas & Josiah my True and lawful Executors
of all & Every Part of this my last Will.
