and Testament in manner and form following

annulling by these Presents all and every Will and
Wills heretofore by me made either by Word or
Writing and first being heartily sorry for my sins
past most humbly desiring forgiveness of the same
I commit my Soul to Almighty God trusting to
be saved through the Merits of Jesus Christ and
my Body to be buried where it shall please my

Executors hereafter named shall appoint and
as to settling my Temporal Estate which it hath
pleased God to bestow upon me do Order give and
dispose the same in manner and form following
that is to say

Item I give and Devise unto my two Sons
John Herbert and Pascon Herbert ^{and to their heirs forever} my House and
Plantation whereon I now live to be equally divided
between them ~~provided they~~ said Son John Herbert
comes to Virginia ^{then} or his son to claim a Mothry
but in case he shoud never come in to claim the same
then I Give and Devise my ^{whole said} House and Plantation

unto my said Son Pascon Herbert Herbert and to his
Heirs forever & paying unto the lawfull Son of the
said John Herbert if he shoud have any ^{living} at my death
the Sum of Two hundred Pounds Current Money and
in Case he shoud have no Son living then I desire my
said Son Pascon Herbert shoud stay unto John Herberts
Eldest Daughter if any the said Sum of Two hundred
Pounds Current money at my death

Item I Give and Devise unto my two Sons Thomas
Herbert and Joshua Curle Herbert and their Heirs forever
my Land and Plantation in the County of Norfolk
to be equally divided between them provided my said
Son Joshua Curle Herbert shoud return to Virginia in
Person to claim a Moiety ^{thereof} But in Case he shoud never
come in to claim the same then I Give and Devise the said
Whole Plantation unto my Son Thomas Herbert and
his Heirs forever ^{on condition that my son Thomas Herbert survives my son Joshua Curle Herbert} But in Case he shoud die before the
said Curle Herbert then I give the whole to Joshua Curle Herbert His Heirs forever

Item I Give and Devise unto my two Sons John Herbert
and Pascon Herbert and to their Heirs ^{forever} my Land and
Plantation laying and being in Elizabeth City County on
Savorys Swamp to be equally divided between them provided
my said Son John Herbert shoud return to Virginia in
Person to claim a Moiety ^{thereof} But in Case he shoud never
return to claim the same then I Give and Devise the
Whole Plantation unto my Son Pascon Herbert and his
Heirs forever

Item I Give and Bequeath unto my Son Joshua
Curle Herbeart the sum of Two hundred Pounds
Current money But in Case He never returns
Home from beyond Sea then it is my will and
desire that the said sum of Two hundred Pounds
be divided in the following manner One hundred
Pounds half of the above sum I Give and Bequeath
unto my Daughter Rosca Tyler Herbeart and the
other One hundred Pounds I Give unto my two Grand
Daughters Judith Curle Armitstead and Elizabeth
Hosley Armitstead equally to be divided between
them

Item I Give and Bequeath unto my Son Pascon
Herbeart three large Table Silver Spoons and three
Silver Tea Spoons.

Item I Give unto my Daughter Rosca Tyler Herbeart
three large Silver Spoons and three Silver Tea
Spoons

Item I Give and Bequeath unto my Daughter Rosca
Tyler Herbeart My Bed and Furniture

Item I Give and Bequeath unto my Son Pascon
Herbeart One Bed and Furniture

Item I Give and Bequeath unto my Grand
Daughter Judith Curle Armitstead one large
looking Glass above Stair

Item It is my Will and desire that after my death

half I Give and Bequeath unto my Daughter
