 pardon and forgiveness of all my sins and a joyfull resurrec-
 tion at the last day as for my body I commit it to the
 earth to be buried at the discretion of my Executors here-
 after named as for that small quantity of worldly goods the
 Lord in his mercy hath lent me after my Just debts is
 paid I give and bequeath in manner & form following -
 Viz. I give and bequeath, unto my brother Samuell Ferguson
 all my land as I have in Kewerly park patent to him &
 his heirs forever. I give and bequeath all of rest
 of estate to my Brother James Ferguson being what
 nature or quality whatsoever saving any young horse I give
 bequeath unto John Gordon, and I appoint my brother
 James Ferguson, sole Executor of this my last will &
 testament. and Lastly I hereby disannul & make void all
 other wills made by me heretofore. and deliver this my last
 will & testament and no other in witness whereof I hereunto
 set my hand & affix my seal this 5th day of November 1777 -
