 is or hereafter shall come to the hands of the sd John Tayloe
 as soon as the sd Orphan shall attain to lawfull age or when
 thereunto required by the Justices of the Peace for the County
 of Essex as also to save & keep harmless the sd Justices their
 heirs & Successors from all troubles damages that shall or may
 arise about the sd Estate Then this Obligation to be null void
 & of none Effect otherwise to remain in full force & Virtue
