In the name of God amen. I Jane Turley of Truro
Parish in the County of Fairfax and Colony of Virginia being
sick and weak in body but of sound mind and memory do make
this my last Will and Testament in manner following. I
Imprimis I give and bequeath to Martha Turley the wife of John
Sampson Turley during her natural life the use of a negro girl
named Nell together with her future Increase and after the said
Martha Turley's decease my Will is that the said negro girl
and her future Increase shall be equally divided amongst my
grandchildren Henrietta Turley, Giles Turley, Martha Turley,
Ann Turley Sampson Turley, Elizabeth Turley and Susanah
Turley and their heirs forever. But forasmuch as the said negro
girl Nell is only mortgaged to me by my son Sampson Turley for
the sum of forty pounds by Deed duly admitted to Record in Fairfax
County which mortgage is not yet perfected. If therefore my son Sampson
Turley shall hereafter redeem the said negro girl by paying the said
forty pounds within the time limited in the said mortgaged Deed
Then and in that case it is my Will that the said forty pounds so
paid shall be equally divided amongst my said grandchildren above
named. Here I give to Martha Turley the wife of my son Sampson
Turley my blue cloth cloak. Here I give to my granddaughter
Jean Turley two feather beds and furniture as they shall be found
standing below stairs at the time of my decease. Also one large
iron bound blue chest, one red trunk, one Teakettle and set of Tea
ware, two Iron Pots one large & the other middle sized, six pewter
Dishes, one dozen of Silver Plates, six pewter Basons, one silver
dressing glass, half a dozen base knives and forks, one bay onare
called Langer one side saddle with a blue slip cover and Bridle

One Diaper Table cloth, six diaper napkins, my suit of silk
blossoms, consisting of a gown and Petticoat, my spinning Wheel Wor-
ron and heaters and all the Wood & Cotton which shall be in the house
spun and unspun at the time of my decease. Here I give to my
granddaughter Henrietta Turley one Feather bed and furniture as it
shall be found standing in the second room above stairs at the time
of my Decease, Also a middle sized brown hair Trunk, four pewter
Dishes, six pewter plates one iron pot, one grey spade Ware, my other
side Saddle which is without a cover and the bridle. Here I give to
my granddaughter Martha Turley one feather bed and furniture as
the same shall be found standing in the first room above stairs at the
time of my death. Here I give to my granddaughter Ann Turley
my other feather bed and furniture as the same shall be found stan-
ding in the Closet at the time of my death. Here I give to Mary
Walden my black bumbazine Gown and Petticoat. Here I give
to John Walden son of John Walden and Mary his wife one three
year old black Ware Colt. Here I give to my friend John Filler one
bow and ball. Here I give to Elizabeth Connell twenty shillings
Current money. Here I give to my grandson John Turley my
large Bible. Here I give to my grandson Giles Turley one
three years old bay Ware. Here it is my Will that all my wear-
ing Apparel (except what is already given, and such as I may
hereafter think fit to bequeath by word of mouth) shall be equal-
ly divided between my two granddaughters Jane Turley and
Henrietta Turley. And it is my Will and desire accordingly I do
direct and order, that all the rest and residue of my estate what-
soever and wheresoever not herein before given and bequeathed
shall be sold by my Executors herein after named as soon as
conveniently they can and the money arising from the sale
thereof (after paying my just debts) I give to my grandson
John Turley to be paid him by my Executors at his age of twenty
one years and not before, neither to him nor to any Guardian he
may choose nor to any person whatsoever in his behalf, it being
my desire that the said money shall remain till that time in
the hands of my Executors. And lastly I do nominate &
appoint
