bequeath to my son William Jones one hundred and fifty
Acres of Land to be his and his heirs forever.

and I give and bequeath unto my son David Jones three negroes to wit
one named Joseph to my son John Jones one negro boy
named John to my son James Jones one negro boy
named Mary. In trust with my Executor to so with
at their discretion so long as he lives and at his death the
above said negroes to be sold and divided among all his children
I give and bequeath to my son James Jones part of the
said whereon I now live containing one hundred and thirty three
acres be the same more or less beginning at Martin Kings road at
the old boat landing thence up the road to a red oak chapel nearly
opposite where the road leading from Barnardsburg to Martin
Kings runs into Martin Kings road thence a chapel line running
across two branches to another bridge thence to the river
thence with the river to the beginning to him and his heirs for-
ever. Also I give and bequeath to my son James Jones one square
strip of Land on the North side of Martin Kings road to him
and his heirs forever further I give and bequeath unto my son James

above boy Archon should be sold to the highest bidder within months next and the money arising therefrom to be divided in manner and form following - I give and bequeath to my son Roland Jones one hundred dollars to him and his heirs forever I give and bequeath to my son David Jones one hundred dollars to him and his heirs forever - The balance of the money I give to my wife Sally Jones to do with as she may think proper - Signed and acknowledged the said David Jones on this eighth day of January one thousand eight hundred and seventeen

This I shall together with the said order of the Court and this day in open Court proved by the oath of the said James and Daniel M.
