one Khan Horse Junr, all my sheep, Two sows and seven Shoats, all my
Powder pots and Cove Knives and forks Both my wheels and carts,
and all my plantation tools, and at her Death or marriage to be
Equally Divided among my children Nancy Ferguson Susannah
Greer Stephen Wood Junr. Franky Chambers (and my Daughter
Smiths three orphan children Betsey Law John Smith and Stephen
Smith) to keep and Enjoy one sixth part of the above property to
them and their heirs forever, and my Daughter Polly Kofz Dec.
her five Children Sarah Kofz Thomas Kofz Elizabeth Kofz David
Kofz and Nancy Kofz to keep and Enjoy one sixth part of the above
property to them and their heirs forever, it is to be understood that
my children above named is each to keep and Enjoy one sixth
part of the above property to them and their heirs forever, and
the Land James Williamson now lives on to be laid off Beginning
on William Cochran line at the mouth of s. Williamsons Spring
Branch and up the same as it meanders to his Spring and
straight on to Michael Hutches line thence to Robert Hasleg line
and along the same to the Beginning I give to said James Williamson
to him and his heirs forever, and all the Rest of my Estate to be
Equally Divided Between my children Betsey Law Nancy Ferguson
Susanna Greer Samuel Wood Stephen Wood Junr. Franky Chambers
and one Eighth part of s. property to be Divided Between my
Grand children Betsey Law John Smith and Stephen Smith to
them and their heirs forever, I also give to my five Grand
children Sarah Kofz Thomas Kofz Elizabeth Kofz David Kofz
and Nancy Kofz one Eighth part of the s. property to be Divided
Equally amongst them to them and their heirs forever I also
appoint Stephen Wood and Moses Greer Junr. Executors to this
my last Will and Testament Ratifying and confirming this

This last Will and Testament of Stephen Wood Jr.
deceased was proved by the oath of Michael Stultz and Robert
Pasley Jr two witnesses hereto and ordered to be recorded. And
on the motion of Moses Green Jr and Stephen Wood the
Executors herein named who made oath as the Law directs
and together with Benjamin Smith and Burwell Law
their securities entered into and acknowledged their Bond
in penalty of four Thousand Dollars conditioned as the
Law directs, Certificate is granted therefor obtaining a
Probate in due form.
