 When it shall be decently buried in christian like manner
 And as for my worldly goods that it hath pleased God to bestow
 me with - I do dispose of in manner and form following
 (to wit) that I give and bequeath unto my wife

I give Margaret Williams the third part of my lands where I now
live during his natural life and the adjoining lands on the South side of
Linking creek to be laid off in such a manner as to include the
Mansion House together with the out houses barn and orchard and
in such a manner that when we may occupy the balance of
the lands may have privilege of the water and the remainder of
my plantation to be sold by my executor and the Rent arising
therefrom to be equally divided among all my Children except
my wife Margaret should need it, in that case to be paid
to her and after the death of my wife Margaret
the above plantation to be sold with the adjoining lands by
my executor for the best price that can be got and the money
arising therefrom to be divided in manner and form following
First One Hundred dollars to each of my five daughters namely
Elizabeth Went, Margaret Park, Polly Hatfield, Susanna
Greene and Catharine Shapard - the remaining part arising
from the sale of said lands to be equally divided among
all my children including the widow Williams now
living children that she had by my son Michael Williams
decd as one heir or legatee - Secondly I do desire that
my tract of Lands known by the name of the Stage house
