and forty two and twenty eight between Alexander McKinney of the first part Esq<sup>r</sup> D.  
French of the second part and Isaac & William Chapman of the third part all of  
the County of Giles and State of Virginia whereas Alexander McKinney is truly in  
debt to the said Isaac & W<sup>m</sup> Chapman in the sum of forty four dollars and  
seventy three cents which will now clearly appear by these notes for that sum  
due this day which the said Alexander McKinney is desirous to secure now this Settlement  
witnesseth that the said Alexander McKinney for and in consideration of the premises  
also for the further consideration of one dollar to him in hand paid by the said  
Esq<sup>r</sup> D French the first writer is hereby acknowledged his greatest Friends  
and to do and to these presents doth hereby grant bargains sell unto the said  
Esq<sup>r</sup> D French the following property this instrument about six years old & one  
half about five weeks ago two Cows and one Calf two little Cows one Horse  
Clouded and has been lame the property is to be sold at public auction or  
being worth \$500 all right house hold and kitchen furniture of every kind and  
description to have and to hold the officers property for ever with the further  
increase upon trust man of the Alexander McKinney shall have and hold \$75.  
the said Isaac & W<sup>m</sup> Chapman the officers sum of forty four dollars and  
seventy three cents with interest thereon from this date and before the 1<sup>st</sup> day of  
November next this obligation to be as a part of the said Alexander McKinney  
shall remain payment of the officers sum of forty four dollars and seventy  
three cents with the interest officers as any part thereof there in that time the  
said Esq<sup>r</sup> D French shall enter and take possession of the officers property  
and enforce them to sell at the highest bidder for ready money by advertising  
the same ten days at the front door of the Court House and out of the window on
