In the name of God amen, I Alexander Roane of Gloucester County being sick & weak of body but of sound mind and perfect memory do make constitute and ordain this present writing to be my last will and testament in the following manner first I revoke & make void all former wills heretofore by me made secondly I recommend my soul into the hands of Almighty God and Saviour my body to be interred at the discretion of Exors. hereafter named and as to what worldly estate it hath pleased God to bless me with I give and dispose of in the following manner (to wit) Item I leave to my Loveing Elizabeth Roane all my lands Negroes and personal estate dureing her widowhood. Item at the marriage of my wife or if she does not marry at her death I give to my son William Roane my mill and all my land over my mill to Norman's Spring branch. Item at the marriage of my wife or if

she never made remainder part of the land that was last Roane all the remaind of sadlers line including a line to me by my father up to sadler lying over spring to me by my father up to Sadler lying over spring of land that I bought of Sadler lying over spring of land that I make the line streight with former line of land that the line streight with former line which will make the line streight with former line which will make the sadder. Item I give to my between my Father and Sadder. Item I give to my between my Posne at the marriage of my wife or if Alexander Roane at the marriage of my wife or if she Alexander Roane at her death the land whereon my dwelling house stands all the land from the line which wells formerly to part my Father and Sadler, from themes up formerly to part my to the great road. Item after to John Wallers path to the great road. Item after the marriage of my wife or if she never marrys at her death I give and bequeath to my son Thomas Roane all the Temporal Court John Wallers path to the Trans der of my land over John Wallers path to the great road and to Newcombs line. Item at the marriage of my wife or if she never marrys at her death I give all negroes and all my personal of every kind to be equally divided among my children (to wit) William Roame, Charles Roane Alexander Roane Thomas Roane Frances Roane Elizabeth Roane and the child that my wife is now big with. Item my will and desire is that if either my son William or Charles decease before they shall come to the age of twenty one years that the survivor of them two shall have the land I give to the deceased one. Item my will and desire is that if either my Alexander or Thomas should decease before they come to the age of twenty one years that the survivor of them two shall have the land I give the deceased one. Item if any of my children should die leaving to child or children lawfully begotten before a division of negroes and personalty should take place I desire that the survivors shall divide the said negroes and personal Estate equally among them when a division shall legally take place. Lastly I appoint my wife Elizabeth Roane, John Kidd, and Christopher Garland Executors to this my last will. In witness whereof I have hereunto set my hand & seal this fourth day of October in the year of our Lord one thousand Seven hundred and eighty four.
