A Schedule of my property in such Societies, I leave with this Testament. My other & equally beloved Children, I trust, & believe are provided for, & will, I think, Cordially agree in the disposition I have thus made of my property.

Praying for Gods blessing on them all. I sign & seal this as my last will & Testament, on this twenty fifth day of Sept<sup>r</sup> in the year of our Lord one thousand Seven hundred and Seventy two.

The annuity, principal and interest due <sup>me</sup> by the estate of the late William H. Roy, of Green Plains, Mathews County of which I leave with this paper a statement up to Sept 1870.

At a Court continued and held for Gloucester County at the courthouse on Tuesday the 5<sup>th</sup> day of February 1878, this paper writing purporting to be the last will and Testament of the Rev. Charles Mann deceased was produced in Court for proof and there being no subscribing witness to the same William J. Robins and John S. Cooke being sworn

Rayfield solemnly depone that they are well acquainted with the handwriting of the testator and verily believe that the said will and Codicil thereto and the signatures thereto subscribed are wholly written in the testator's own hand, whereupon the said paper writing was ordered to be recorded as the true last will and testament of the said Charles Mann deceased and is recorded.

Rayfield In the name of God amen, I Wm Rayfield of the County of Gloucester and State of Virginia being of Sound <sup>and disposing</sup> mind and memory and considering the uncertainty of this mortal life do make and publish this my last will and testament in manner and form following to wit.

William Item First. It is my wish and desire as soon after my death as practicable that all of my just and lawfull debts be paid and settled out of any money belonging to my estate.

Item Second. I lend to my beloved wife Robertie E. Rayfield as long as she remains my widow and no longer, one third of my real estate, whereon I now reside known as Parks Ferry including the dwellings and barns. In event of her marrying or death then I direct the same to be sold.

Item third. I give and bequeath to my beloved wife Robertie E. Rayfield the following named personal property, to wit, all of my household and kitchen furniture, my horse buggy and harness, three choice milk cows and calves, one yoke oxen, Six hundred pounds Pork or Bacon and twelve months supply of Corn and provender for herself and the Stock left her, and the sum of fifteen hundred dollars in money, I
