To the County Court of Green County Your commissioner reports
 to the court that on the day of A D Almond the administrator of John
 A Lee deceased exhibited before your court a statement of all the money which
 he the said A D Almond had received or become chargeable with or he
 disbursed since he qualified as such administrator together with the vouchers for
 such disbursements that the Commissioner embraced the said admin in the list
 of fiduciaries whose account were before him for settlement which was paid
 at the front door of the court house of said county on the first day of December can
 last and on the date of this report ten day having elapsed since the said account
 was presented in the said list made up and completed the foregoing account
 of the said A D Almond administrator of the estate of the said John A Lee deceased on
 on the 1st day of June 1869 finds a balance of \$1408 due from the administrator to the
