statement of all the money which he the said Alexander O.
Bradford had received or become chargeable with, or had
disbursed from the day of June 1853 to the 13th day of
April 1854 together with the vouchers for such disbursements.
That your commissi^on^{er}s embraced the said administrator in
the list of fiduciaries, whose accounts were before him for
settlement, which was tested at the front door of the courthouse
of said county on the first day of April court last, and on
the date of this report made up and completed the foregoing
account of the said A.O. Bradford deceased. The account is
supported by satisfactory vouchers, and is herewith returned.
Your commissi^on^{er}s further reports to the court, that he has
examined whether the said administrator has given such
bond as the law requires, and whether it is in a penalty, and
with securities sufficient, and finds the same to be unobjection-
