

(1) In the name of God Amen I John Morris Senr of the County of
Greensville and State of Virginia being of sound mind and memory calling
to mind that it is appointed for man once to die to make and ordain this
my last Will and Testament that is to say first I give and recommending
my soul into the hands of Almighty God that governs my body I recommend
the same from whence it was taken with a sure hope that I shall raise the
same again at the great and general resurrection by the mighty power of God
and as touching the things of this World, wherein He it hath pleased God
the Lord to bless me I give, dispose, and devise of the same in the manner
following to wit my Will is that all my Just Debts be paid In pursuance I
bequeath to my beloved wife Lucy Morris one Horse the choice of my Stock two
Cows and Calves to young Battle two feather Beds with usual furniture
two Sows and ten Poultry and one third part of my ~~estate~~ ^{estate} of the personal
nature during her natural life to and to be the support of the children
I have had by her the said Lucy I have also lent to my said wife Lucy
Morris the several Land and Plantations during her life or widowhood
with this exception that in case my said wife should live till my son
Wyatt Morris arrives to the age of Twenty one years that my Lands and
Premises before lent should then be sold and the monies arising therefrom
to be equally divided between my said wife Lucy and my five children
namely William James Green Alice and Wyatt Morris with this exception

I do hereby give and bequeath to my son James Green, Alice and Myall children with this exception
 that if either of the above named children dies under age or without lawful issue his or her
 part so devised to return to the surviving part of the above named children
 to them and their heirs forever. Now the residue of my Estate not devised
 given and bequeathed to my son James Green, Alice and Myall and my Daughter Polly
 Sarah & Minnie I give to my son James Green, & Myall and my Daughter Alice
 with this exception that if either of the above named children dies under age
 or without lawful issue his part so devised to return to the surviving part
 of the above named to them and their heirs forever, my Will is
 that all my Estate above bequeathed to my said wife Lucy should at her demise
 be sold, and the monies arising therefrom to be divided between all the
 children I have had by the said Lucy Morris and her Daughter Nancy
 Wilkinson the said Nancy Wilkinson to have five pounds and the balance
 to be equally divided between the said children to them and their heirs forever
 and if either dies under age or without lawful issue his or her part to return to
 the surviving part to them and their heirs forever. Lastly I nominate
 and appoint my said wife Lucy Morris & my son William Morris Executors
 and Executor to this my last Will and Testament and do by these presents
 revoke and disannul all former Wills & Testaments and Provisions thereto by

part so devised, to return to the surviving part of the above named Children
 to them and their heirs forever, when the residue of my Estate not devised, I
 give and bequeath to my Son William Morris and my Daughters Betty
 Sarah & Minnie & my Son James Green & Myrtle and my Daughter Alice
 with this exception that if either of the above named children die without
 or without lawful heir then part so devised to return to the surviving part
 of the above named to them and their heirs & assigns forever, my Will is
 that all my Estate above lent to my said wife Lucy should at her decease
 be sold, and the monies arising therefrom to be divided between all the
 Children I have bore by the said Lucy Morris and her Daughter & Son
 William the said & my William to have five pounds and the balance
 to be equally divided ^{between} the aforesaid Children to them and their heirs forever
 and if either dies under age or without lawful issue his or her part to return to
 the surviving part to them and their heirs forever. Lastly I nominate
 and appoint my said wife Lucy Morris & my Son William Morris Executors
 and Executor to this my last Will and Testament and do by these presents
 revoke and disannul all former Wills & Testaments and pronounce this to be
 my last will & Testament Witness my hand and seal this 22nd day
 of October 1803.
