me appointed for man to die as a mortal and to leave this my last will and testament, in manner
and form following - I declare that my Estate both of personal and real Estate I give and bequeath
to my loving sister Mary Adams my two Negroes to wit my Negro man Will and one Negro woman
Sally and their increase I give to my aforesaid sister Mary Adams for and during her life and at
her death or decease I leave them to be divided among her children to wit, John Adams, Thomas
Adams, David Adams, Ann Adams, James Adams, and Emmanuel Adams all which I give to
them and their heirs forever - I then I give and bequeath to William Thompson one
feather bed and furniture all which I give to him and his heirs forever - I then I give and bequeath
my two Nieces Daughters of Daniel Adams Rebecca and Elizabeth Adams each one a habit as new
all which I give to them and their heirs forever - I then I give and bequeath to my Niece Polly Adams
Daughter of Elizabeth Adams one Habit to her and her heirs forever - I then I give and bequeath
to my Niece Ann Adams daughter of my Sister Elizabeth Adams my Cardinal to her and her heirs
forever - I then the remainder and residue of my Estate both real and personal of what kind so
ever after my just debts are paid I give and bequeath to my loving sister Mary Adams and her

beis found - I am I nominate and appoint my friend James Adams whole and sole
 Executor to this my last will and testament and do hereby ratify and firm this and no
 other to be my last will and testament - I do hereby reserve disallow and dis annul all former
 wills testaments and Legacies and Executors heretofore by me in any wise named In witness
 whereof I have hereunto set my hand and affixed my seal this fifth day of February A.D. 1806
 one thousand eight hundred four.
