I Thomas Malone of the County of Greensville and State of Virginia do hereby make
my last Will and Testament in witness and form following that is to say - First I desire
that all my just debts and funeral Expenses be paid by my executor herein after named
as soon as he conveniently can - 2nd I give unto my nephew William Wyche son of David
Wyche my riding saddle - 3rd I give unto my nephew Thomas M Malone son of Joseph
Malone five Dollars to be laid out in books - 4th I give unto my two half sisters Frances
Wilkins and Patsy Holts twenty Dollars each to buy them a suit of Cloths - 5th My will
and desire is after the payment of my just debts and the Expenses above mentioned, that all
the rest and residue of my estate real and personal be kept together under the direction
of management of my wife Mary E Malone for her support & the support and education
of my son David M Malone during my wife's widowhood or untill my son David arrives to
the age of Twenty years At the happening of either of these events I desire my Estate real &
Personal may be divided allotting to my son David two thirds thereof & to my wife Mary
the remaining one third for and during the term of her natural life and at her Death
to descend to my Son David - But should my son David M. Malone depart this

during the life time of my wife Mary and before he arrives to the age of twenty years
in that case I give unto my wife Mary O'Malone the following Negroes to wit James
Peter, Louisa, Mary and her five children John, Doctor, Jerry, Harriet, & Charles
and their future increase to her and her heirs in fee simple forever. All the balance
of my Estate real and personal after the death of my son David should that happen
before he arrives to the age of twenty years. I desire to be divided one moiety of which
I give to my sister Elizabeth Wagoner and the other moiety I desire to be divided
equally among the children of my sister Sally Davis wife of Robert H. Davis to them
and their heirs forever. And should my son David survive my wife Mary & pass
his life before he arrives to the age of twenty years then and in that case I give the
here mentioned Negroes to wit James Peter, Louisa, Mary and their five children John,
Doctor, Jerry, Harriet & Charles and their future increase to the Mason family the
relations of my wife Mary O'Malone to them and their heirs forever. And lastly
I hereby constitute and appoint my friend Edmund Mason Executor to this my
last testament hereby revoking all other a former will or testament by me here
before made. In Witness whereof I have hereunto set my hand & affixed my seal
this Twenty ninth day of October in the year of our Lord one thousand eight
hundred and fifteen
