 manner and form following (Vizt; first I give to my Sister Winifred Johnson the
 Land and plantation whereon I now live beginning at a pine ^{tree} at the Mill path at
 Timothy Ellens ~~see line~~ thence down as the Croft fence goes to the great branch thence
 down the said branch to the Beaver pond Creek thence down said Creek to Middlebury
 branch thence up said branch to Ellens line thence along the said Ellens line to the
 beginning also four Negroes namely Ben, Betty, his wife Isaac and John also four
 Cows and calves also one horse a dark bay and one Dragoon fully with a sufficiency
 of plantation utensils to work her said lands &c with to be left to two good men chosen
 for that purpose for which my said Sister Winifred Johnson is to have the right to
 name the two men herself. And also I give her two sows and pigs and also a suffe-
 ciency of pork for her one year and seventy five barrels of fall Corn also two feather-
 beds and double set of furniture her choice, also one large covered trunk also one blue
 painted chest one press and as many of Butter and fall pots as she wants, six knives
 and forks, and six plaster plates, also fodder sufficient for her stock, one year wear
 six rolling chairs, also one pair of flat Irons, also one pine table but in case my said
 Winifred John should die without an heir lawfully begotten of her body then and in

following property to wit two Negroes namely Ellen and Cherry which is to be put in
possession of my brother William Johnson till Samuel Johnson arrives to the age of twenty
one years for the purpose of their here to school said Samuel Johnson which said two
Negroes I give to him and to his heirs lawfully begotten. Thirdly I give to Daniel
Johnson the following property to wit one Negro Girl named Mason to have her heirs
&c forever. fourthly I give to John Johnson the following property to wit one Negro boy named
Blatome to him ^{his} heirs &c forever. fifthly I give to my brother James Johnson two hun-
dred Dollars to him his heirs &c forever sixthly I give to my Brother William John-
son all the balance of my estate both real and personally of any nature or kind
whateaver provided he pay my just debts to him forever my will will & desire is that my
Brother William Johnson and my sister Mirified Johnson take the proper of John
and Daniel Johnsons and keep for them till they arrive to the age of twenty one years
Seventhly my will and desire is if either of the aforesaid Legatees should die with-
out an heir lawfully begotten in that case the surviving ones in that case is to have

following property to wit two Negroes namely Allen and Cherry which is to be, just
possession of my brother William Johnson till Samuel Johnson arrives to the age of
one year for the purpose of their here to school said Samuel Johnson which said
Negroes I give to him and to his heirs lawfully begotten. Thirdly I give to Daniel
Johnson the following property to wit one Negro Girl named Mason to him his heirs
& forever. fourthly I give to John Johnson the following property to wit one Negro boy named
Clatbone to him ^{his} heirs & forever. fifthly I give to my brother James Johnson two hun-
dred Dollars to him his heirs & forever. sixthly I give to my Brother William
son all the balance of my estate both real and personally of every nature or kind
whatsoever provided he pay my just debts to him forever my will and desire is that my
Brother William Johnson and my Sister Minified Johnson take the proper of John
and Daniel Johnsons and keep for them till they arrive to the age of twenty one years
Seventhly my will and desire is if either of the aforesaid Legatees should die with-
out an heir lawfully begotten in that case the Surviving ones in that case as to have their
proportionable part. Eighthly and lastly I nominate and appoint my Brother William
Johnson and my friend Benjamin Woodroff Sole Executors to this my last will and
Testament looking all all other Wills by me made, signed, sealed & known ledged in
presence of us

365/ County the 8th day of August 1814. This Will was proved by the Oaths of the Witnesses there
to and ordered to be Recorded. And on the motion of Benjamin Woodrooff one of the Execu-
tors therein named who made Oath Thurst and together with August Maffey, Nathaniel
Peebles and Samuel Ament his Securities entered into and acknowledged their bond in
the Penalty of Twenty Thousand Dollars Conditioned as the Law directs Certificate is
granted the said Benjamin Woodrooff for obtaining a probat of the said Will in due
form.
