Bob, Ben, Archer, Harbert, Tom, Eaton, Chloa, Leggy, Phillis, Hannah, Selmy, Sarah, Manue
and Sealey. Them and their increase, if any, forever together with every species or kind of property that
I am, or may hereafter be possessed with, or that may become due, or owing to me, after my decease,
except two negroes, which I shall mention in the preceding clause, all which I give to him, & his

heirs forever. — Item I give and bequeath unto my grand daughter Sam Anderson, (who now

this my will, and in confirmation of the whole I have set my hand and seal this sixth day of January
