 and forgiveness of all my sins and that my Soul with my
 Body at a General day of the Resurrection shall come
 with joy and through the Merits of Christ death
 properly and Inherit the Kingdom of Heaven with
 his Elect and Chosen and my Body to be Buried in a
 Manner and now for the settling of Temporal Estate or
 such Goods Chattles as it hath pleased God to bestow upon
 me I doe order Give and dispose the same in manner
 and form following after my Lawfull debts is paid then
 I Give & Bequeath to my Son William one Negro bo
 named Harry and Lot of Land where he now Lives &c
 I Give and Bequeath to my son John Addams one
 Negro boy named John & 300 Acres of Land adjoining
 to one William that I Bought of Peter Little &c
 George Addams one hundred acres the said tract is
 the North Side of the Creek. Item I Give and
 Bequeath to my son Joshua Addams a Negro boy na
 med Peter and the Land and Plantation on Sandy Creek
 where I did dwell. Item I Give and Bequeath to my
 Daughter Elizabeth Addams one Negro Girl named
 Sarah. Item I Give and Bequeath to my Daughter Mary

Address me Negro Girl named Feltie. Item I give
 Bequeath to my Daughter Martha one Negro Girl
 named Hannah and Negro Sarah I Desire shall be
 sold and what she fetches to be Equally Divided amongst
 all my children and all my Movable Estate ^{to be} Divided
 By three good House Keepers amongst all my children
 Before signed I leave all my Estate to my Wife Elener
 Adams during her Widowhood and after her Marriage
 all to Return to ^{my} children as I have before mentioned
 I leave my Wife my sole and sole Executor, Witness
 my hand and seal this 2d day of March 1769.
