In the Name of God Amen. I John Boman
Senr. being in sound memory Thanks be to God for the same, do make this
my last will & Testament, in manner and form following. I first
my beloved Wife Barbary during her natural life, or widowhood, all my estate
of what nature or kind soever. Item after my Wife's decease or Marriage I give
my son Bibby that piece of land I bought of John Royall lying on South Side of
leaf branch. Item I give and bequeath to my son. Fuldaing the remainder of my
land I purchased of J. Royall. Item I give and bequeath to my son John Boman
that part of land (being part of the tract I bought of Peter Crowder) lying joining
of his containing one Hundred & fourteen acres. Item I give and bequeath to my son
Edward five pounds ten Shillings to be paid to him out of my estate by my executor.
Item I give and bequeath to my sons Amstead & Spencer Boman the land I
now live on containing three hundred and eighteen acres including the land I had

Thos Thomas also the residue of the land I bought of Crowder adjoining the place
called Ephraim's Rally, also the tract I bought of my Brother Tho Bomar
containing (by a late Survey) Seventy six acres, all the residue of my Estate of
what nature or kind soever, I leave to be equally Divided Among my sons
already named my Daughter Susanna Hodges my son Ruben and the
orphans of Wm Bomar Dec^d (I mean the orphans is to have a child's part, divid
ed equally amongst them, and to be paid to each as they come to the years of
maturity by the executors. It is further my will that in case of either sons
dying, in Spencer's day, without heirs of their own Body, that their
part be equally divided as above directed. Lastly I Nominate, Constitute &
Appoint my friend James Bruce, my sons Bibby & Fielding Bomar, my
Beloved Wife, to be Executors & Executrix of this my last will and testament
hereby revoke all others, in Witness whereof I have set my hand and affixed
my seal This 4th January 1799.

At a court held for Halifax County the 22nd day of April 1799
The within Written last will and Testament of John Bomar dec^d was
exhibited in court and proved by the oaths of three Witnesses thereto subscribed
and ordered to be recorded and on the motion of Bibby Bomar and Fielding
Bomar two of the Executors therein named who made oath according to law
Certificate is granted them for obtaining probate thereof in due form, they giving
Security whereof the said Bibby Bomar and Fielding Bomar with James
Bowie and John Light their securities entered into and acknowledged
their Bonds in the penalty of Ten Thousand dollars conditioned according
to law and ~~James Bowie~~ Bowie the other Executor and the ~~Executors~~ named in the
said Will having refused to take upon themselves the burden of the execution
thereof the same is ordered to be certified
