Copy of the Will of Barbara Dickie.

I Barbara Dickie formerly of the County of King & Queen now residing with James Edwards in the County of King William being of sound mind and disposing memory thanks be to God & knowing the Certainty of death & the uncertainty of life do make and ordain this my Last Will & Testament in manner & form following viz:

Item I give & bequeath unto my sister Janet Ray wife of Beverly Ray a horse of her Choice out of my stock

Item I give and bequeath unto Mariana Dickie daughter of my brother James Dickie a negro Woman by the name of Hannah, and another by the name of Eve.

I give & bequeath unto Frances Dickie another of said James a young Woman by the name Philadelphia

I give and bequeath unto William Dickie son of said James
a negro boy by the name of Beverly.

I give and bequeath unto Fernald Dickie a daughter of
said James a negro girl by the name of Linton.

I give and bequeath unto Janet Dickie daughter of said
James the following negroes to wit a girl by the name of
Caroline, Minny & a boy James.

I give and bequeath unto Elizabeth L. Dickie another of said
James my horse and gig, the above named children
being the children of my said brother James Dickie. The
property, I have given them specifically, I give them &
their heirs each instead of give it to my brother.

I give and bequeath unto Jennett Edwards daughter of
James & Mary Dunbar Edwards my plantation in King
and Queen County Longing Dragoon Swamp con-
taining to the best of my knowledge about nine
acres be it more or less.
