Copy of the Will of Sarah Hambleton

In the name of God Amen

Sarah Hambleton of the County of Louisa and State of Virginia
make and publish this my last Will and Testament in manner and

as following (that is to say)

First I give and devise To my Grand Son David Richardson a

Woman named Nancy and her future increase to him

his heirs forever but it is my Will that his mother my

daughter Ann Richardson shall be supported by him during

her natural life. I also give him my cupboard. I give and

devise to my Son David Hambleton one negro woman named

Mary with her future increase to him and his heirs forever.

I also lend him a negro man named Nat. during his natural

life and at his death I give and devise the said negro Nat

to my two grandsons Oliver Ellsworth Hambleton and

his share to them and to his 8.

my two grandsons Oliver Ellsworth Hamblton and
James Madison Hamblton to them and their heirs forever
it in case either of my grandsons Oliver Ellsworth Hamblton
or James Madison Hamblton or both of them should
without lawful issue their part or parts to dying I give
and devise to my grand daughter, Polly, Hamblton and
her heirs forever.

and devise to my grand daughter Rebecca Harris
a Negro Woman named Bing with her future increase
her and her heirs forever, but it is my Will that she
shall let her mother my daughter Jane Harris have the
use of the said negro Bing and her increase during her
natural life but in case my grand daughter Rebecca
Harris should die without lawful issue then and
that case I give and devise said negro Bing
with her future increase to the children of her son
James Hamblton but none of them being at the time
of my death.

Share and Share alike Which I give to them and
their heirs forever, but it is to distinctly understood
that the said children are to let their mother Ann
Johnson have the use of said negro Bing and
her future increase during her natural life but
in case my grand daughter Rebecca Harris should
die without lawful issue I give them in that case
I give and devise said negro Bing with her future
increase to the children of her sister Ann Johnson
that may be living at the time of such death to
be divided among them share and share alike Which
I give to them and their heirs forever.

I give and devise to my grand daughter Mary Ann
one negro boy named Dick and to dispose of him at
her death in any manner she may think proper
I give and devise. I give and devise to my grand
daughter Sarah Hoggard one feather bed with its
pillow and bolster and all the

furniture to her and her heirs forever. All the residue
of my estate of every description Whatsoever.

I give and devise to my two daughters Susanna
Richards and Elizabeth Sharp to them and their
heirs forever.

I hereby constitute and appoint my Son David
Hamilton Executor of this my last Will and Testament
hereby revoking all former Wills by me made.

For Witness Whereof I have hereunto set my hand and
affixed my seal this first day of January one thousand
eight hundred and thirteen.
