-ne this my last will & Testam^t in manner & form following

Imprimis I Recommend my Soul to Almighty God that gave it & my Body to the
Earth to be decently buried at the discretion of my Execut^r

Item I Give unto my Son Tarlton Woodson all that tract of Land commonly
called Neck of Land & Swamp to him my said Son & his heirs for ever likewise
give unto my s^d Son Tarlton about A Thousand Acres of Land lying
in Henrico County at Dover on the North side James River beginning at the
upper line of Charles fflomming & bounded up the River to John Pleasantston
near the Mouth of Bauer Dam Creek & so out into the Woods & so on the back
lines to come Opposite to the Lower line of the said fflomming thence to the
fflomings corner Tree & so along his back line & upper line to the place be
gan to him my said Son Tarlton & his heirs for ever

Item I Give unto my Son Jacob Woodson one tract of Land at Dover lying
in Henrico County begining at Samuel Birks lower line thence down the River
to the lower Tide of the mouth of Janitoe Creek thence into the Woods to the head
line of that Survey, binding on my old Survey, & then up the back lines up
the River ward till it comes to his Brother Tarltons lower line thence on
line & the lower line of Samuel Birks to the place began unto him my s^d
Son Jacob & his heirs for ever

to the River & place began including my Corn Mill & all that part of
Sabot Island which lies Opposite to the said tract bounded by a strait
line Ten pole below the mouth of mill Creek & crossing the little River to the
Island & so crossing the Island I Strike the main River forty pole below
the house of John Prior all which I give unto my said Son In & his heirs
for ever.

Item I give unto my Son Robert Woodson one tract of Land begining at
his Brother Johns lower line at the River thence down the River fifty
Pole below the mouth of Stony Creek thence on a strait line at right

angles from the River six hundred Yards out thence on a shait line, to shike my back line fifty pole below where the said line crosses stoney Creek.

Thence on the said back lines to his Brother Johns Lower line near where I have given Josiah Paine a hundred Acres so to bind on his Brother Johns lower line so to the River unto him my s^t. Son & his heirs for ever including my Sawmill & Appertenances to be belonging & that part of Sabot Island which reaches from his Brother Johns line in the S. Island till it comes fifty poles below the mouth of stoney Creek & from thence a shait line to be run to the South or main River unto him my s^t. Son & his heirs for ever. Item. Give unto my Son Josiah one tract of land, beginning at his Brother Roberts lower line thence down the River to the mouth of a Gully below where John Maxfield now dwells. thence into the Woods at right angles from the River to be back line thence on the s. line to his Brother Roberts lower line thence on that line to the place began, thence over the little River binding on his Brother Roberts lower line in Sabot Island to the main South River thence down the S. River till it comes opposite to a Gully near where John Maxfield now dwells unto him my s^t. Son Josiah & his heirs for ever.

Item. Give unto my Son Stephen one tract of Land begining at his Brother Josiahs lower line thence down the River to John Hickabys. thence out into the Woods at right angles from the River, to be back line, thence on yt. line to his Brother Josiahs lower line, thence on yt. line to the place began I fleskwise give unto my s^t. Son Stephen the remainder of Sabot Island from Josiahs lower line to the lower end of the S. Island. both land & Island unto him my s^t. Stephen and his heirs for ever.

Item. Give unto my Daughter Judith one tract of Land on James River, begining at her Brother Stephens lower line on the River thence down the River half a Mile thence into the Woods at right angles from the River to yt. back line of the land, Surveyed by William Womack thence on yt. line till it comes opposite with her brother Stephens lower line, thence on yt. line to the River & place began, unto her my s^t. Daughter & her lawfully begotten heirs for ever. Item. Give unto my Daughter Elizabeth one tract of Land begining at her Sister Judiths lower line, thence down the River half a Mile. thence at right angles from yt. River to the back line of the Land, Surveyed by W^m Womack thence on that line to her Sisters lower line, thence on that line to yt. River & place began unto her my s^t. Daughter & her lawfully begotten heirs for ever.

Item. Give unto my son Jacob Woodson one tract of Land opposite Elk Island where Joshua Stephens now or of late did dwell containing by patent three hundred forty eight Acres, unto him my s^t. Son & his heirs for ever.

Item. Give unto my Sons Josiah & Stephen my land at half Sink lying on Chickahominy Swamp in Henrico County. Except One hundred & fifty Acres to be bounded on the line of John Pirant & the Swamp. all the rest I Give unto my s^t. Sons to be equally divided Josiah to have the upper part & Stephen the lower part, unto each of my s^t. Sons their s^t. equal parts severally & not jointly & unto each of their heirs for ever.

he his heirs Execut: &c shall well & truly pay unto my Daughter Elizab
the money sufficient to purchase a good Negro that then I give the Land

Item. I do hereby Impower will & desire my Execut^r to sell all my tract
of Land called Bear Forrest lying on Allens Creek & do Moreover fully
impower them or some of them to make Deeds of sale for the same the pro-
duct of which I Give to all my Children, to be equally Divided.

Ilem. Give unto my Son Tarlton a Swamp called peirces Swamp to him
& his heirs for ever.

Ilem. I Give my personall Estate to be divided into eight parts that

I also Impower my Exec^r to Confirm unto Thomas Hawood one hundred & fifty acres of Land at half sink bounded on Rians line & the Swamp provided he shall well & truly pay them Three Thousand four hundred Pounds of Lawfull Tobacco.

Item. I will that my Son Tarlton shall Confirm unto my Brother Benj' Woodson the land he . . . lives on at Chickahomony Swamp.

Item I will that my Son Tarlton shall confirm unto John Cannon son of W^m & Judith his wife one hundred acres of Land up James River like wise one hundred acres to W^m Cannon provided he pays to my Exec^r Ten Pounds Country pay.

Item. I will that he Confirm unto Cha: Huddesey one hundred acres of Land for which I have recd. payment & one hundred more if the s^t Huddesey does well & truly pay 80 Bushels wheat & bring it to Dover mill.

I Further will & hereby Impower my Exec^r to confirm unto Edw^r Lester a dividend of Land in Mill Creek which I formerly bargained for.

I also Impower my Exec^r to confirm unto Henry Lester two hundred acres of Land up mill Creek provided he will pay him

Twenty Pounds Currant money.

I also I empower them to Confirm unto Robert Hughes three hundred acres of Land being part of five hundred for which I have Charles Flemings bond for the remaining two hundred to John Jones of Manakin Town.

One hundred Acres I will may be confirmed to W^m. Thornell lying between Robert Adams & the line of Richard Woodson provided he shall well & truly pay Ten pounds ready Cash. I further will that if any one or more of my Children should dye without heirs or before they arrive to the Age of twenty One Years that then his heir or their Estate shall be equally divided among the Survivors & the heirs of such as reach us have arrived to the Age of twenty one Years or have had lawfull heirs before they arrive to that Age to be equally divided.

And lastly what real Estate moveable, or immovable, not heretofore given, I give to my Execut^t hereafter named, to them, their heirs & assigns, for ever, hereby nominating, & appointing my Sons Tarlton Woodson, John Woodson, Robert Woodson & Jacob Woodson to be my Execut^t to this my last will & Testam^t, revoking all other wills by me heretofore made. As witness my hand & Seal this 25th day of November anno Domⁱ 1715.

and Matthew Dod three of the witnesses thereto, and was thereupon

To all Christian people to whome these presents shall come knowne you that I John Ellis of the County of Henrico planter, for divers good causes, & considerations me here to moving, but more especially for the sum of five thousand Pounds of every way good Tobacco, so me in hand paid by Robert Napier of y^e same County y^e receipt whereof I hereby acknowledge & my self fully contented & paid, have Bargained & sold & doe by these presents Bargaine & sell to y^e Robert Napier his heirs & assigns for ever, one tract or parcell of Land lying & being in the afores^t County by Estimation one hundred & fifty Acres be the same more or less, & bounded as followeth beginning at y^e mouth of Peters Branch where it mouths into Tuckahoe Creek & so up that branch y^e severall courses thereof till it comes up to Ellis Back
