

In the Name of God Amen I Godfrey Fowler of Henrico County  
 being in perfect health and sound memory thanks be given to God but know-  
 ing the uncertainty of this life do make constitute and ordain this to be my  
 last Will & Testament in manner & form following First I desire that my  
 son John Fowler may have the whole Use Benefit & Advantage of the planta-  
 tion whereon he now lives with all the Land on the North Side of the spring  
 branch during his Natural Life, or his abode upon the said plantation &  
 after his Death or Removal I give & bequeath the aforesaid plantation and  
 Tract of Land to my Grandson Godfrey Fowler son of Mark Fowler to him  
 & his Heirs for ever Then I give my son Godfrey Fowler the plantation and  
 Tract of Land whereon he now lives lying on the South Side of the aforesaid  
 Spring branch bordering Cattail Creek to W<sup>m</sup> Dunnifent's Spring Branch  
 hence keeping that branch to the line to him & to his Heirs for ever Then I de-  
 sire that my Daughter Phoebe widow of my Deceas<sup>t</sup> Son Thomas Fowler may  
 have the whole Use Benefit & Advantage of the plantation & Tract of Land  
 whereon my aforesaid Deceased Son Dwell Containing two hundred  
 acres or be the same more or less as it is already laid off by markt Trees  
 &c during her Natural Life or widowhood and after her death or marriage  
 I give the aforesaid plantation & Tract of Land to my two Grandsons William & John  
 Fowler Sons of my aforesaid Son Thomas Fowler to them and to their Heirs for ever  
 to be Equally Divided between them Then I give & bequeath unto my Son mark Fowler  
 the plantation & Tract of Land whereon he now lives Containing two hundred  
 acres as it is already laid off by markt Trees &c to him & to his heirs for ever  
 Then I give & bequeath unto Thomas Ellis the plantation & Tract of two hun-  
 dred acres of Land whereon he lately Dwell as it is already laid off by markt  
 Trees &c to his heirs for ever it being the Tract of Land w<sup>c</sup> he bought  
 of my Son Joseph Fowler & the Right not yet Conveyed Then I give and be-  
 queath unto John Smith one hundred acres of Land or to the same  
 more or less laying upon the Land which I have given to  
 Thomas Ellis to him & to his Heirs for ever he having fully &

Satisfied me for the said Land & the right not conveyed before.  
 Then I give my son Joseph Fowler One Shilling Sterling Then I give  
 my Daughter Anne Hill one Seal Skin Trunk Then I give my  
 son Mark Fowler all the Cattle he has of mine in his possession &  
 the Debt which he owes me Then I give my Daughter Martha  
 Vodon One Leather Chair which she has now in <sup>her</sup> possession I desire  
 that my Estate may not be appraised till the rest of my Estate  
 of Nature or kind sooner I give <sup>unto</sup> my son Godfrey Fowler & his Constitu-  
 tute & appoint my said son Godfrey Fowler my whole & sole Executor  
 of this my last will & Testament ratifying & confirming this and no  
 other to be my last Will & Testament In Wiltshire whereof I have here-  
 unto set my hand & affixed my seal this 29<sup>th</sup> day of June 1748  
 Signed Sealed published & declared Godfrey <sup>his</sup> Fowler <sup>mark</sup> Seal  
 by the s<sup>r</sup> Godfrey Fowler to be his last Will & Testament in presence of us  
 John Parkinson, Henry Dance, attick moore,

At a Court held for Dennis County the first Monday in May 1747  
 This Will was presented by the Ex<sup>r</sup> herein named upon his solemn  
 affirmation he being a Quaker & proved by the Oath of John par-  
 kinson & Henry Dance two of the Witneses thereto & was admitted to record.
