who gave it when it shall be his pleasure to call me out of this World I give and bequeath unto my
two Brothers Josiah Woodson and Stephen Woodson all my Land lying at Dover and bounded to the south
the lines of old Nat^l Marrisson John Fleming and Cap^t John Woodson and binding on a Creek known by
y^e Name of James Creek which Land I give unto my Bro^s and their heirs for ever It also my Will that my
Brothers should make over and confirm unto Sam^l Burk by a Lawfull Deed of Conveyance and acknow-
ledge the same in open Court Three Hundred and forty eight Acres of Land lying in y^e County of New-Hampshire
and bounded by James River y^e bird Creek and the lines Cap^t Mays for which y^e Sam^l Burk has my Bond for
It is also my Will that my said Brothers should have all Tobacco mon^y Debts and Dues which shall
be due unto me the said Jacob Woodson they paying all Lawfull Debts that shall come against my Estate
which I desire should be legally discharged then it is my Will that my Brothers shall take in possession all
my Lands & Dues what ever I do also appoint my said Brothers Josiah Woodson and Stephen Woodson to be my
Lawfull Executors Witnes my hand this fourth Day of July one Thousand seven Hundred and Twenty
