

commenced as follows beginning at an ash stump on the river bank parting the said John Redford and the said Dudley Diggs from thence up the river to the mouth of a branch, thence up the west fork of the branch to its head thence to the main Road such a course as to continue its breadth; thence along the road to the line between the said John Redford & John Pleas thence up that line North North east to the head corner five hundred South East one hundred and sixty nine poles thence South South West one mile to the place began containing three hundred acres more or less which Land was granted by patent unto Joseph Pleasants deceased and by the said Joseph Pleasants sold unto the said John Redford together with all houses outhouses orchards gardens fences and appurtenances to the same belonging or in any wise appertaining to have and to hold the said Land and premises with their and every of their appurtenances unto the said Dudley Diggs and to his heirs for ever. And the said John Redford doth hereby Covenant and agree to and with the said Dudley Diggs that the said John Redford the above sold Land and premises will for ever warrant and defend unto the said Dudley Diggs his heirs and assigns against all persons whatsoever. In witness whereof the said John Redford hath hereunto set his hand and seal the day and year above written.
