In the Name of God Amen I William North of the Parish and County of Henrico being in perfect Sense and Memory and Considering the frailty of this mortal life doe make this my last will and Testament as followeth Viz first I bequeath my soul to God that gave it and my body to be buried after a Christian manner and all my worldly debts to be Justly paid and my worldly Goods I give and bequeath in manner and form following Viz- Item I give and bequeath unto my son John North Two Hundred acres of Land out of ~~the~~ four hundred Acres which I bought of Thomas Cottrel Lying and being in the County of Albemarl to my said son John his heirs and Assigns for Ever Item I give and bequeath to my son William North the Other two hundred acres of Land which I bought of the Said Tho: Cottrel in Albemarl County to my said son William his heirs and Assigns for Ever Item I give and bequeath unto my Son Abraham North one Certain parcel or tract of Land

which I thought of the said ~~the~~ ^{the} ~~tract~~ ^{tract} lying on the upper side of Deep
Run in Henrico County containing by Estimation or Seventy five Acres
unto my said son ~~Thomas~~ ^{Thomas} his heirs and assigns for Ever Item I give
and bequeath to my son Thomas North one certain Parcel or Tract
of Land containing by Estimation Eighty ^(Acres) Including the Seventy
one acres which I have patented in my own Name and Taking in
likewise a small part of the tract whereon I now live Divided by a
line of marked Trees made by me to my son Thomas his heirs
and assigns for Ever Item I give and bequeath to my son Anthony
North all the rest of the Tract of Land whereon I now live (after his
Mothers Decease but I leave it to her for her lifetime) I say to my
said son Anthony his heirs and assigns for Ever. Item I give and
bequeath to my son Richard North a Negro Girl Named Sarah
to be Delivered unto him when he shall attain to Twenty years of age
only the first two Children as she shall bring shall be disposed as
hereafter mentioned but the said Negro Girl and all the rest of her
Increase to my said son Richard his heirs and assigns for Ever. Item
I give unto my Daughter Susanna the first Surviving Child that my
Negro Girl Sarah shall bring the said Child to be raised and brought
up for her with the mother of it untill my said Daughter do either
marry or shall attain to the age of Eighteen and in Case the said
Negro Girl should never breed that then my said Daughter to
have five Pounds paid her out of my movable Estate. Item I give to
my Daughter Mary North the Second Surviving Child that

my said Negro Sarah shall bring the said Child to be raised and brought up for her with the Mother of it untill my said Daughter shall either Marry or attain to the age of Eighteen years and in case the said Negro Girl should never breed that then my said Daughter to have five Pounds paid her out of my movable Estate. Item I leave to my well beloved wife Susannah North all the rest of my Estate in whatsoever manner and form it be During her natural Life or Widowhood and at her death or marriage to be Equally divided among my Children and my will and desire is that all my Children shall be at Liberty to work for themselves at the age of Eighteen years and that there should be no appraisment of my Estate and I do appoint my two Sons John and William Joint Executors of this my last Will and Testament Signed with my hand and Sealed with my seal this Eighth Day of August. 1747.
