 Estate and disposed of including my Son namely Jonas Holladay and my Daughter
 Mary Knott they are to have their Equal parts in & personal Estate
 given in this paragraph to my Grand Children being to be Divided in to
 five parts only my waving aparell & of Doves next - - -
 Item I give and bequeath all my waving aparell woolen and Linen unto
 my Son Jonas Holladay & my Grand Son Wm Knott Equally to be Divided
 Item and Lastly I do hereby nominate and appoint my Son namely Jonas
 Holladay and my Grand Son namely stathony Coventon Holladay to
 be Exrs of this my Last will & testament and that of house and no
 - grove and plantation or Remain in the hands of my Son Jonas Hol
 - laday until my Grand Son stathony Comes to age In testimony
 Whereof I have here unto set my hand & fixt my seal this 3^d day
 of January Year of our Lord 1718

 perfect sense & memory thanks be to God Do ordain this my last will and
 Testament first I Bequeath my Soul to almighty God who gave it me my
 maker and redeemer in whom I hope for salvation and for forgiveness
 of my sins & my body to be decently buried in & Earth from whence it came
 by my Loving wife or my Exrs here after named -

Item I Give and bequeath to my Loving Wife Elizabeth Groff all my Land
 whereon I now live for her life and after her Decease I Give & planta
 - tion whereon I now live to my Son Francis Groff and the heirs of his
 body Lawfully begotten for ever of & Land beginning at & mouth of a
 small Creek or branch that parts of plantation where I now live to
 and of plantation where my father lived and so up the Road to
 branch to & head line all that part of my land I Give to my Son

Francis afore said -

- Item I Give & bequeath to my Son Thomas Gross all my Land on y^e Southwest Side of y^e gul or branch that is y^e plantation where on my father lived and so up y^e gul or branch to y^e head line all that Land I give to my Son Thomas and y^e heirs of his body Lawfully begotten for Ever & if it should please God that either of my sons Francis or Thomas should Die without heirs Lawfully begotten then I give his part of my Land to my Son Joshua and y^e heirs of his body Lawfully begotten for Ever & if it should please God that two of my sons should die without heirs then their parts to go to my surviving Son -
- Item I Give to my Daughter Hannah a new feather bed Rugg and blanket and 1 pair of Sheets -
- Item I Give to my Daughter Hannah three Cows -
- Item I Give to my Daughter Hannah four pretty Large pewter Dishes and six pewter plates and one horse Collar -
- Item I Give to my Son Thomas one new feather bed -
- Item I Give to my Son Thomas two Cows -
- Item I Give to my Son Francis one Large Gun -
- Item I Give my Son Thomas one narrow that he Rides -
- Item I Give my Son Thomas one Short Gun and 1 short Table -
- Item I Give to my Son Francis one Long Table -
- Item I Give to my Son Joshua one negro Coll that belongs to y^e mare I gave to my Son Thomas -
- Item I Give to my Daughter Mary five or two Sheep -
- Item I Give to my Daughter Elizth Hines two Sheep -
- Item I Give to my Daughter Susannah Long two Sheep -
- Item I Give to my Loving Wife and my Son Joshua all y^e rest of my Estate that is I give my Wife y^e use of it for her Life & I Do ordain and appoint my Loving Wife Elizth Gross and my Son Joshua to be my hole & Sole Ex^{ors} of this my Last will and Testament as Witnes of my hand & Seal this 29 Day of November 1718
