my soule to god whoe gave it me and to Jesus Christ my only saviour and redempter my body to Christian
buriall as for my worldly estate I dispose of it as followeth

- Item I give and bequeath unto William Murphy son: my plantation wherof I live to gather with all the land
I now posside duringe his natural life and after his decease to his sonne William Murphy son: to have and
hold for ever
- Item I give and bequeath unto William Murphy son: all my stocke of Cattle: and hogges he payinge by John
Lawrence and John Jordan: two Cowes gotten
- Item I give and bequeath unto James Dyer the sonne of Nicholas Dyer the two Cows four Calves one Heifer
which his father hath in possession together with the one halfe of the messuage wherabouth I live to age
Item I give and bequeath to Nicholas Dyer the other halfe of the messuage of the above mentioned Cattle
- Item I give unto Margaret Murphy daughter to William Murphy one feather Bed one Stugg one pair
of blankets one pair of Curtains and ballins one pair of Sheets one bolster one pillow one low case
Item I give unto Margaret Murphy all my pewter one grate Iron pot one small Iron pot one grate
table and two formes
- Item I give unto Michell Murphy my house
- Item I doe ordaine and appointe William Murphy son: to be my sole and whole Executor of this my last
Will and Testament receivinge al other Wills and Testaments by me formerly made as in and by the which
I have hereunto set my hand and Seal this 22 day of August 1686

Matthew Tomlin beinge sick and weak in body yett blessed be god in sound and perfect memory do
make this my last Will and Testament in maner and forme followinge: my soule I give and bequeath
my soule unto the hands of almighty God my maker and my body to the earth to be buried in Chris
tian buriall I do justly believe that all my sins shall be forgiven and that I shall rise at the last: my
amongst the elect and chosen of God as for any other worldly good or estate of which the Lord
my maker hath bene pleased to bestow upon me I give and bequeath as hereafter followeth

- Item I doe give and bequeath to John Turner one parcell of land which I have formerly marked for him
beginninge at the mouth of a branch at a marked beech and soe alonge the said branch to the mouth of an
other small branch; and soe alonge the said little branch to a line of marked beeches and soe alonge the
line of beeches to a white oak beinge a Course line from thence north 320 pole to a marked pine
and then beginninge at the said beech againe runninge eastward to the said pine: all the land by me
the south side of the swamp to be for him and his heires for ever: and all that lyeth on the north side
to be for his daughter Mary Turner my grand child: alsoe I doe give to the said Mary Turner of our County
a black Cow of about four years old: the other a brown Cow of about the same age: and a Couple
of Stages both alike to buy her a mare to be delivered after my decease: as fraim as her father will
give them
- Item I doe give and bequeath all the rest of my land and all my moveable estate to be equally divided betwixt
my sonne Matthew Tomlin and my grandson Matthew Tomlin, all the land by me on the north side of
the swamp next John Bulgham to be for my grand sonne: and all on the south side to be my
sons
- Item I doe give and bequeath unto my sonne Matthew Tomlin the plantation wherof on Richard Bracwell

265 now liued for him and his heires for ever I appoint my sonne Mathew Comlin to be whole and sole
Executor of this my last Will and Testament as witness my hand and seal the 14th day and year above written

in full body full of goods and perfect memory thanks be to god do make and ordaine this to be my last Will and
Testament in maner and forme following: first I give and bequeath my soul to God my lawier and to mine and my
body to be buried in such decent maner as my Executor shall thinke fitt and as to my worldly estate I give as
followeth all my just debts being first paid

- 1st I give and bequeath unto my son Richard all this plantation now lying on to him and his heires for ever only
my sonne Thomas to live on the plantation until Francis flood shall be expired
- 2^d I give unto my sonne Thomas all that plantation which Francis flood now doth lye on; for ever
the rest of my estate I give and bequeath to my loving wife and their children my loving wife to
enjoy the whole duringe her widow hood but after her marriage the said estate to be equally divided betwixt
her and their children; further I do hereby make my loving wife whole and sole executrix
- 3^d I do hereby constitute and ordaine Henry Gault executor to this my last Will in witness whereof I have hereunto
set my hand and seal the 14th day and year above written

I Richard Ralfe of the shire of Wight County being through the mercy of God in perfect health sound
and memory do make this my last Will and Testament in maner and forme followinge

- 1st I give and bequeath unto my sonne Richard Ralfe the two hundred acres of land with all the houses and di
versities thereto belonging and to his children after him: and for want of issue then I give and bequeath it to
my sonne Cornelius and his children: and for want of issue to my sonne John: then I give and bequeath it to my daughter
Elizabeth: Sara: Mary and Elizabeth and their children for ever
- 2^d I give and bequeath unto my dearest wife duringe her natural life the new dwelling house with all other di
versities and one hundred acres of land adjoining thereto being part of the above mentioned two hundred acres
of land and after her decease then to be equally divided
- 3^d as for my personal estate it is my Will it be divided into three parts: the one third part I give to my wife and
for the other two thirds I give it to be equally divided amongst my children that I now have or shall have at my
decease to be paid them by my Executor at the age of twenty and one years: and if any of them dye before
they come to age: then to be equally divided amongst them that survive I nominate and appoint my dearest wife
Elizabeth Ralfe executrix of this my last Will and Testament revoking all former Wills further
more I do appoint John Copeland Daniel Sandburne William Cudoland and Edmond Bilson Cursors to
see this my Will performed: In witness hereof I have hereunto set my hand and seal this 14th day
of September one thousand six hundred eighty and six
