Item I give and bequeath unto John Johnston 3ells of the best dowles I have now in my Custody

Item I give and bequeath unto my Cousin John Williams all the things that his late wife of myn in many long & tedious in number: with the tools and implements belonging thereto: only this said John Williams my Cousin is to make two pair of shoes apiece for my family that remaineth and out pair of shoes for my man Thomas Williams against he is free, and in performance thereof all accounts to be settled between us, likewise I do appoint unto my man Thomas Williams for his free and lawful attorney Coke a pair of fine woollen drawers again of Canvas drawers two shirts a felt hat again of shoes and stockings:

Item I give and bequeath unto my Cousin Sarah Williams my daughter Janes best hat of apparel & 10 shillings

Item I give and bequeath unto Boaz Swin one barrow hogg of two years old but the next fall: now before the performance of this Will and Testament: my desire and Will is that my wife if in last life she happen that it please gods good will she for to enjoy the plantation and manor house for life and to have my whole estate in things until my sons and daughters come of years except such as I have part and legacies and with all I do appoint my before named friends and ours to be assisting to my wife in the management of the same likewise I require them to be ready and assisting in the performance of this my last Will and Testament and I do utterly forbear and renounce all former Wills either made or spoken in contrivance whereof I have hereunto set my hand and Seal this tenth day of October 1687

In the name of God Amen

Daniell Miles aged fifty years or there about being sick in body but in perfect memory & sense this fore I do make and declare this my last Will and Testament in manner and form as followeth I give I do bequeath my soul unto god who gave it me and my body to the earth from whence it came and for my worldly goods after my debts being truly paid I give as followeth

First I give my eldest son John Miles eight hundred pounds of tobacco to be paid in such good as is in the house as my wife his mother thinks best I give unto son Edward my horse and his furniture and a feather bed and all its furniture that belongs unto it and again a brass kettle and two painted dishes

I give and bequeath unto my youngest son Daniell two Cowes and a feather bed and furniture belonging to it, and four or five dishes and one brass kettle I give unto Elizabeth Cotton one Cow or four or five hundred pounds of tobacco, which my wife can best spare

For the gift of my worldly goods both movable and immovable both with in and without doors I give unto my wife I do appoint my wife to be my true and lawful executrix of this my last Will and Testament I have hereunto set my hand and Seal this present first day of March 1687
