and Ordain this my last Will & Testament, my principally and first
of all I give and bequeath my soul into the hand of God that gave it &
for my Body I command it to the Earth to be buried in a Christian like
and Decent manner to the Discretion of my Executors nothing doubting
but at the General Resurrection I shall receive the same again by the
Mighty of God and as touching such worldly Estates which it hath
pleased God to bless in this life I give & devise & dispose of the same in the
following manner & form

I Give and bequeath unto my Son William Scaboth the plantation with
I now live on and his heirs for ever the Land running to a branch running
near to his brother John Scaboth

I Give and bequeath to my Son John Scaboth the Remainder part of my
Land on the same side of that branch which he now lives on to his heirs for
Ever I Give and bequeath to my Son Tho: Scaboth One Cow & Calf -

I Give and bequeath to my Son Edward Scaboth One two year old Heifer

I Give and bequeath to my Son David Scaboth One two year old Heifer

I Give & bequeath to my Son Samuel Scaboth One two year old Heifer

I Give & bequeath to my Daughter Jane Scaboth One two year old Heifer -

I Give & bequeath to my Daughter Sarah Scaboth One two year old Heifer

I Give and bequeath the Remainder of my Estate to my beloved wife
Sarah Scaboth the remainder part to her Disposal amongst her Children
and this I Order my Will to be prove proved without Scrivinity or prese-
ment of my Estate my Plantation during her life or Widowhood & then
to my Son William Scaboth with the land thereto and I do hereby give
unto her all the Remainder part of my Estate and I do hereby make &
Appoint my Wife Sarah Scaboth and Will: Scaboth my son in hole an
sole Executors of this my last Will & testament With my Revoking and
making voided all wills before made by me In Witness whereof I have
hereunto set my hand and Seal this ninth day of November in the year
of our Lord 1735
