I James Garner of the County of Suffolk being in Newport Parish being Weak of Body but of perfect Sense and Memory do make and declare this my last Will and Testament. —

Item. I give and Bequeath to my Son John Garner the lower part of the Plantation that I now live on — Bounded as followeth Beginning at a Red Oak Corner Tree of Joseph Garner's so running to a large Gum in the Mouth of a Branch to him and his Heirs forever.

Item. I give and Bequeath to my Son Jesse Garner to him and his Heirs the Plantation that I now live on; and in Case that my Son Jesse should die without Heir, — then I give it to my Son Joseph Garner and his Heirs and in Case that he should die without Heir, then I give it to my Son James Garner and his Heirs. —

Item. I give to my Son John Garner my old long Gun. —

Item. I give to my Son Joseph Garner my new long Gun. —

Item. I give to my Son Jesse Garner my little Gun. —

Item. I give to my Son Joseph Garner my young Horse. —

Item. I give to Jesse Garner my Mare Colt. —

Item. I give to my Son James Garner my old Mare. —

I also give to my Son James Garner a Cow & Calf. —

Item. I give to my Daughter Sarah Garner five Shillings. —

Item. I give to my Daughter Olive Garner five pounds. —

Item. I give to my Son Jesse my Whip Saw. —

Item. I give the Remainder of my Money to be equally divided between my Sons Joseph and Jesse. —

Item. I give to my Son Joseph my great Chest. —

Item. I give to my Son Jesse my new Chest. —

Item. I give my Son Joseph my new Bed & Furniture belonging to it. I also give my Money Scales to him. —

Item. I give to my Son Jesse the Bed that I lie on & furniture belonging to it. —

Item. I give my other Bed and Furniture belonging to it to my Daughter Olive. —

between John, and Joseph and Jesse and James & Olive
after the Charges of my Funeral is paid.
And I also appoint my Brother Joseph Garner and
my son Joseph Garner my whole and sole Executors of
this my last Will and Testament. As Witness my
Hand and Seal this 22nd day of July 1748.
