Item. I Give to my Son William Bridge five Shillings

Item. I Give to my Granddaughter Mary Bridge. Daughter of my Son Joseph Bridge One Cow

Item. I Give to my Granddaughter Huziah Bridge One Cow

Item. I Give to my Granddaughter Sarah Bridge One Cow

Item. I Give to my Granddaughter Ann Bridge One Cow

Item. I Give to my Granddaughter Fester Bridge One Cow

My Will is that all the Rest of my Estate. whatsoever be sold at publick Sale. and to be equally divided amongst my Children whose Names followeth. (Viz^t) Martha Jones. Margaret Jorrich Mary Bridge. Agatha Bridge. and Nathania Bridge

Item. I Do. Ordain and Appoint my Sons in Law John Jorrich & Joseph Jones. my whole and sole Executors of this my last Will and Testament. and to see hereby revocable. and make
