ecutors nothing doubting but at
the general resurrection I shall
receive it again by the mighty
power of God and as touching
such worldly estate which
it has pleased God to bestow
upon me within this life I give and devise

and dispose of the same in the following manner and form first I loan unto my beloved husband all my land his life after his death my desire is that Charles W. Moore and George Moore my two Sons shall have the land except ten acres which I loan to my daughter Catharine Moore for life, after her death to James Moore in fee simple my desire is if my son Charles W. Moore never have a lawful begotten heir of his body that my son George Moore may have the land in fee simple to him and his heirs forever After his death my desire is that my daughter Nancy Williams shall have twenty five cents of my estate and no more, and my desire is that my son Lodwick Moore shall have twenty five cents of my estate and no more. I appoint my beloved husband Lewis Davis my executor to this my last will and testament. Lastly I do hereby disallow revoke and annul all ^{testament} every former will legacies bequests executors by me in any way before named void and bequeathed ratifying and confirming this and no other to be my last will and testament.
