

indenture made the first day of March Anno Domini 1806 between Bartholomew Lipscomb of the County of King William of the one part and Phillip Lipscomb of the same County of the other part Witnesseth that whereas the said Bartholomew Lipscomb is justly indebted to James Lipscomb in the sum of two hundred and fifty pounds and is anxious to secure and ensure the payment of the said sum of money with all interest that may grow due from the date of these presents moreover in consideration of making a provision for the payment of the said debt he in consideration of the sum of five shillings to the said Bartholomew Lipscomb in hand paid by the said Phillip Lipscomb the receipt whereof is hereby acknowledged. The said Bartholomew Lipscomb hath granted bargained sold aliened and transferred and by these presents doth grant bargain sell alien and transfer unto the said Phillip Lipscomb his executors or administrators the following slaves to wit Aggy, Nee John Beverly and Russell and the undivided third proportion of the Slaves held by Pamela Madison the widow of Thomas Chamberlayne deceased to which said third proportion the said Bartholomew Lipscomb became entitled by his intermarriage with Lucy Chamberlayne a daughter of the said Thomas Chamberlayne to have and to hold the said slaves Aggy Nee John Beverly and Russell and the said third proportion of the slaves held by Pamela Madison during her life as the widow of Thomas Chamberlayne dead to the said Phillip Lipscomb his executors or administrators forever to his and their proper use. To have full force and upon the conditions and such as to be understood as the true meaning of these presents that the said Phillip Lipscomb his executors or administrators shall at any time required by James Lipscomb his heirs executors or administrators having previously advertised at the Court house of King William County for three weeks the time and place of sale make sale of the said Aggy, Nee John Beverly and Russell and the third proportion of the slaves held by Pamela Madison during her life as the widow of Thomas Chamberlayne deceased as is aforesaid for ready money with the future increase of the said Slaves or such a proportion of the conveyed property aforesaid as will be sufficient to pay the incidental charges of carrying this trust deed into effect and to pay to the said James Lipscomb his heirs executors or administrators the sum of two hundred and fifty pounds with all interest that may grow due thereon from the date of these presents and any surplus money arising from the sale of aforesaid property after paying the incidental charges that may accrue in carrying this trust deed into effect and after paying the debt of two hundred and fifty pounds with the interest that may grow due thereon the said Phillip Lipscomb his executors or administrators shall pay to the said Bartholomew Lipscomb his heirs executors or administrators. And the said Bartholomew Lipscomb being possessed of an absolute and indefeasible estate in the said slaves Aggy Nee John Beverly and Russell doth hereby covenant with the said Phillip Lipscomb that he his heirs executors or administrators shall meet with no hindrance or obstruction in making sale of the said slaves according to the intention of these presents that the said Phillip Lipscomb

his executors or administrators may at any time when thereto required
 executors or administrators take into his or their possession the said slaves with their
 and sell the same or so many of them as may be sufficient to raise the sum
 and the said Bartholomew Lipscomb covenants for himself his heirs executors or administrators
 no suit or action shall be commenced or sustained against the said Philip Lipscomb
 executors or administrators for any proceeding or conduct which here they may pursue con-
 forming with the intention of these presents. In witness whereof the parties to these presents

The Commonwealth of Virginia to Honor Littlepage Montague Williams and John Lord
 Gentlemen justices of the County of King William greeting whereas William Watkins and Susanna
 his wife have by their indenture of bargain and sale bearing date the 28th day of April 1802 sold and
 conveyed unto Isaac Quarles one certain tract or parcel of lands containing by estimation eighty nine
 to be the same more or less lying and being in the said County and whereas the said Susannah came
 conveniently hither to our County Court of King William to make acknowledgment of the said con-
 veyance, therefore we do give unto you or any two or more of you power to examine her privately and
 take her acknowledgment concerning the conveyance aforesaid contained in the said Indenture
 which is here annexed and we command you that you personally go to the said Susannah and
 examine her privately and a part from the said William Watkins her husband concerning
 her executing the said Indenture and take her acknowledgment thereof and when
 you have examined her as aforesaid and received her acknowledgment that you do truthfully
 and plainly certify to us that of us our said Court annexed to this writ Witness Robert Pollard
 Clerk of our said Court the 25th day of June 1806 in the 30th year of our foundation
